We respectfully submit this estimate for the following services at 221 Main St. La Crosse, WI 54601. The estimate will include the following tasks:

Parking Ramp Crawlspaces

- 1) City parking authority will be required to block off the parking spots in front of crawlspace access.
- 2) SERVPRO will be detaching the metal grate and loosen cables for access to crawlspace (nightly).
- 3) Job site trailer to be placed onsite, if needed. Equipment set up and taken down per crawlspace areas nightly.
- 4) Crawlspaces; Per Section Technician time manually removing pigeon remains and feces.
- 5) Crawlspaces; Per Section Haul all bags of removed waste from crawlspaces for offsite disposal.
- **6**) Crawlspaces; Per Section Vacuum rubber roof surfaces and fixtures, post waste removal.
- 7) Crawlspaces; Per Section Pressure wash rubber roof and all fixtures.
- 8) Crawlspaces; Per Section Squeegee and rinse rubber roof.
- 9) Nightly inspection of business's and sidewalks below the parking ramp area. Clean up as needed.
- 10) Final jobsite walk through and sign off with city parking representative.
- 11) Job site break down & clean up.

Description of Process per Level

Parking Ramp Crawlspace; dry and wet methods of cleaning will take place during the remediation. All areas will be sprayed damp to reduce aerosolizing of particulates during the removal and bagging process. The areas will be vacuumed to remove any left behind waste and dust, post waste and remains removal. The crawlspace areas will then be pressure washed and squeegeed. All exterior portions of the ground level businesses will be inspected and cleaned as needed.

Cost

As stated above the specifications we propose to furnish material and labor for the sum of: **Forty Two Thousand Seven Hundred Ten and 68/100** Dollars (\$42,710.68).

Payment schedule as follows: Balance due upon completion.
