AN ORDINANCE to amend Section 115-110 of the Code of Ordinances of the City of La Crosse by adding thereto new territory and making additions and corrections to the zoning map (1350 Nakomis Ave. - Uhls).

➤ **BACKGROUND INFORMATION:**

Dean and Diane Uhls petitioned to have their property annexed from the Town of Campbell to the City of La Crosse in 2017. This amendment adds this parcel to the zoning map as Single Family Residence District (R-1).

➤ **GENERAL LOCATION:**

1350 Nakomis Ave., as depicted on **MAP PC17-1135.**

➤ **RECOMMENDATION OF OTHER BOARDS AND COMMISSIONS:**

The Common Council approved resolutions 17-0813 accepting the petition for direct annexation and 17-0814 annexing this parcel on August 10, 2017.

➤ **PLANNING RECOMMENDATION:**

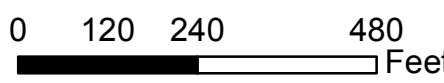
Planning staff recommends approval.

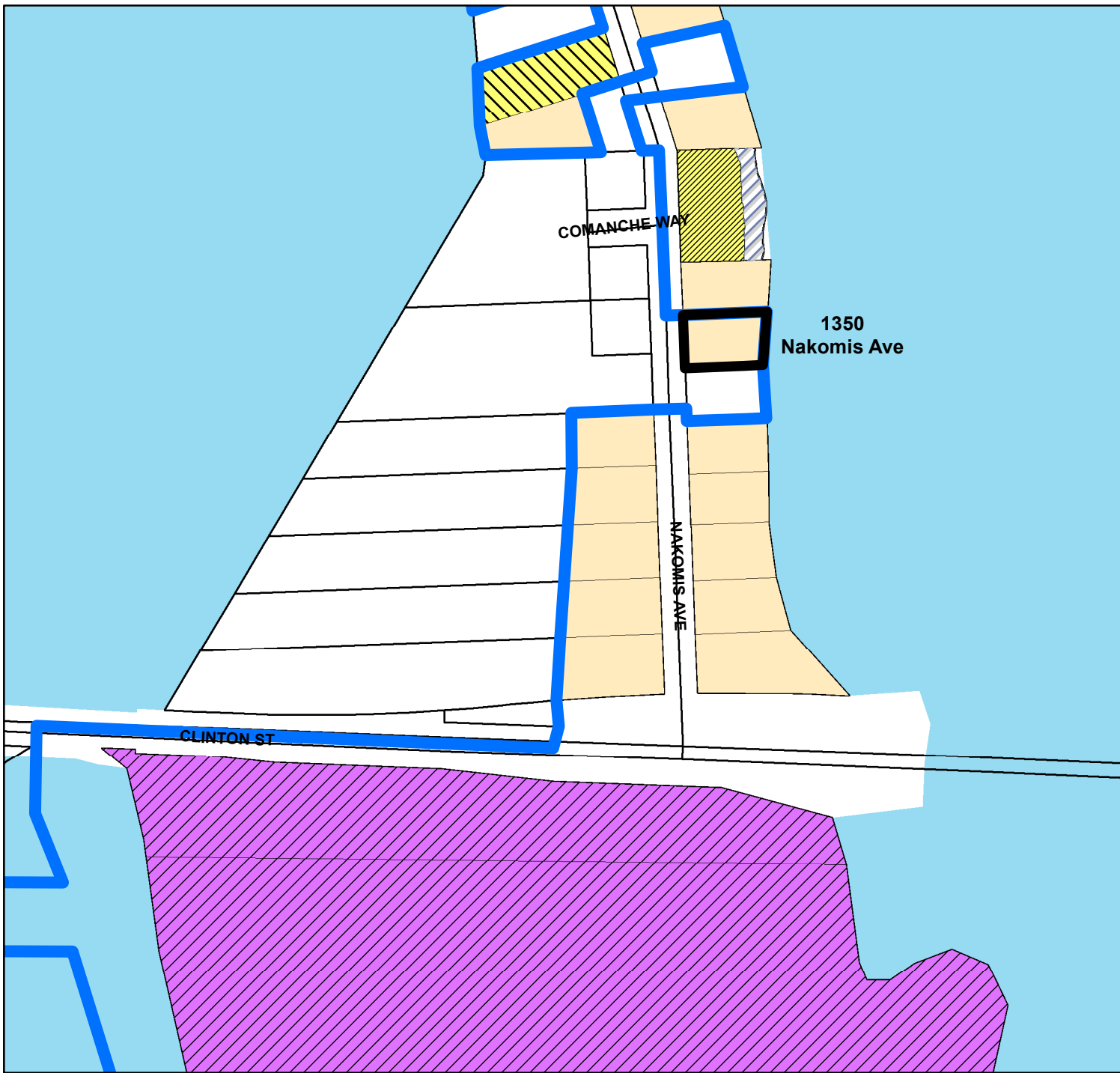
