We did not buy this house with the intent of running it as a rental property, but as a home for our son. Our son for several years had been in trouble which resulted in some costly legal expenses. Therefore, this situation made it impossible for him to secure decent living accommodations in the LaCrosse area. Before we bought the home on Prospect St., he had rented about 12 rooms or apartments in LaCrosse that could be categorized as substandard living conditions or (slums) cheap, shabby living accommodations. He had no quality of life. During this time we had very little contact with him. He has had a hard time obtaining and holding onto employment because of the past events. Even though he hasn't been in trouble since we bought the home, his past is recorded on the internet and is still there to haunt him with every job application even though he has made restitution.

My wife and I are retired and living on a fixed income. We couldn't really afford it, but we bought the home as a last ditch effort to help our son. When we first bought it, he helped a little toward the mortgage giving him some pride in ownership of the home. Due to an on the job injury, however, he lost his full time job. We refinanced the home twice to make the payments more affordable for us while paying the closing costs. He helps when he can but has paid no money this year. He finally has seen a little success that was a long time coming. He was involved step by step in the improvements made to this house to make it his home. The neighbors all say it looks great. He is friends with many of his neighbors who all watch each other's' properties when one is gone. He is very proud of himself and his home and continues to work odd jobs while seeking a permanent position. He has plans yet to make even more improvements to the condition of the home.

You say he is a renter, but he pays no rent. He lives there with his two little dogs. He maintains the property inside and out and has only enhanced its value. Again this isn't a normal rental with transient tenants. The only occupant is our son.

We hope that our honesty has not backfired. It's hard to believe that we can't buy a home to help our son, let him live in it, fix it up, giving LaCrosse more tax money, and you could say "vacate" when we have also enhanced the value of the neighborhood. We feel that if the home gets taken away because of this moratorium, our son will once again regress to a state of depression and dispair along with my wife and my self.

No one knows our son isn't the owner. The house really has never been advertised as a rental. We consider the home more of a healing factor because it has brought our son back into our lives and given him hope. We don't want to relive those days wondering where and how he was.

According to recent articles in the paper, he would be hard pressed to ever own property without our help. Also, this is a chance to get what you consider a rental back to a single family home if you give us a waiver and some time.
