2. Special Report- Brenda Rooney-Food Desert in La Crosse

Food insecurity was identified by United Way in 2012 as a health concern in La Crosse due to the presence of food deserts. Food deserts: low income census tracts that lack access to a grocery store within one mile of the center area. Food deserts identified in Powell, Poage, Hamilton and Northside neighborhoods.
