AN ORDINANCE to amend sec.  
40-15 of the Code of Ordinances of  
the City of La Crosse regarding  
adoption by reference of the Public  
Right-of-Way Accessibility Guide-  
lines (PROWAG).

THE COMMON COUNCIL of the  
City of La Crosse do ordain as  
follows:

SECTION I: Section 40-15 is  
hereby amended to read as follows:  
Sec. 40-15. - Adoption of Public  
Right-of-Way Accessibility Guide-  
lines.

Design and construction of trans-  
portation infrastructure in public  
ways, including but not limited to  
roadways and sidewalks, shall meet  
the minimum standards of the final  
rule made by the U.S. Access Board,  
published in the Federal Register as  
36 CFR Part 1180, also known as  
the Public Right-of-Way Accessibility  
Guidelines (PROWAG).

The City of La Crosse shall create  
its own minimum standards, as long  
as they are compliant with the  
standards of PROWAG, and shall  
incorporate them into the City of La  
Crosse Standard Specifications &  
Procedures and Standard Detail  
Drawings sheets. Such standards  
shall be reviewed and updated  
annually, with approval by the Board  
of Public Works or its designee.

SECTION II: Should any portion of  
this ordinance be declared unconsti-  
tutional or invalid by a court of  
competent jurisdiction, the remainder  
of this division shall not be affected.

SECTION III: This ordinance shall  
take effect and be in force from and  
after its passage and publication.
