ORDINANCE NO. 4950
AN ORDINANCE to amend Secs. 10-756 and 10-757(10) of the Code of Ordinances of the City of La Crosse relating to charitable organizations and exemption from a Direct Sellers Permit.
THE COMMON COUNCIL of the City of La Crosse does ordain as follows:
SECTION I: Section 10-756 is hereby amended to add a definition as follows:
Sec. 10-756. - Definitions.
Charitable purpose means a benevolent, educational, philanthropic, humane, scientific, patriotic, social welfare, advocacy, public health, environmental conservation, civic or other eleemosynary objective.
SECTION II: Section 10-757(10) is hereby amended to read as follows:
Sec. 10-757. - Exemptions.
(10) Any charitable organization established for a charitable purpose and registered under Wis. Stat. § 440.42 with the State of Wisconsin, provided that there is submitted to the City Clerk proof that such charitable organization is registered. All persons exempt under this subsection shall be required to comply with the applicable regulations. Any charitable organization not registered under Wis. Stat. § 440.42 with the State of Wisconsin shall be required to obtain a license under this section.; provided, however, all persons exempt under this subsection shall be required to comply with applicable regulations;
SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of the article shall not be affected.
SECTION IV: This ordinance shall take effect and be in force from and after its passage and publication.
