ORDINANCE NO.: 5001
AN AMENDED ORDINANCE to amend Section 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Planned Development District - General to the Planned Development District - Specific at 529 Park Plaza Drive allowing for a mixed use residential development with changes to original design.
THE COMMON COUNCIL of the City of La Crosse do ordain as follows:
SECTION I: Section 115-110 of the Code of Ordinances of the City of La Crosse is hereby amended by transferring certain property from the Planned Development District - General to the Planned Development District - Specific on the Master Zoning Map, to-wit:
17-20246-31. CERTIFIED SURVEY MAP NO. 14 VOL 17 LOT 1 DOC NO. 1683829.
17-20246-32. THAT PRT LOT 2 LYG NLY OF N LN LOT 1 HOESCHLERS PARK PLAZA ADDN EXTD WLY TO THE WATERS EDGE.
SECTION II: This ordinance is conditioned requiring the stormwater management plan be revised and resubmitted for approval by the Design Review Committee prior to receiving a building permit for the units that are being relocated on the site plan.
SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.
SECTION IV: This ordinance shall take effect and be in force from and after its passage and publication.
