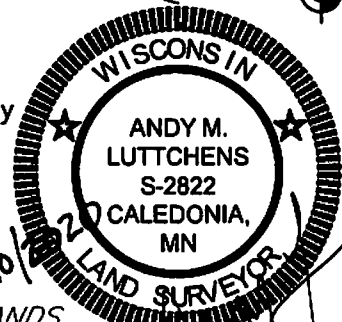
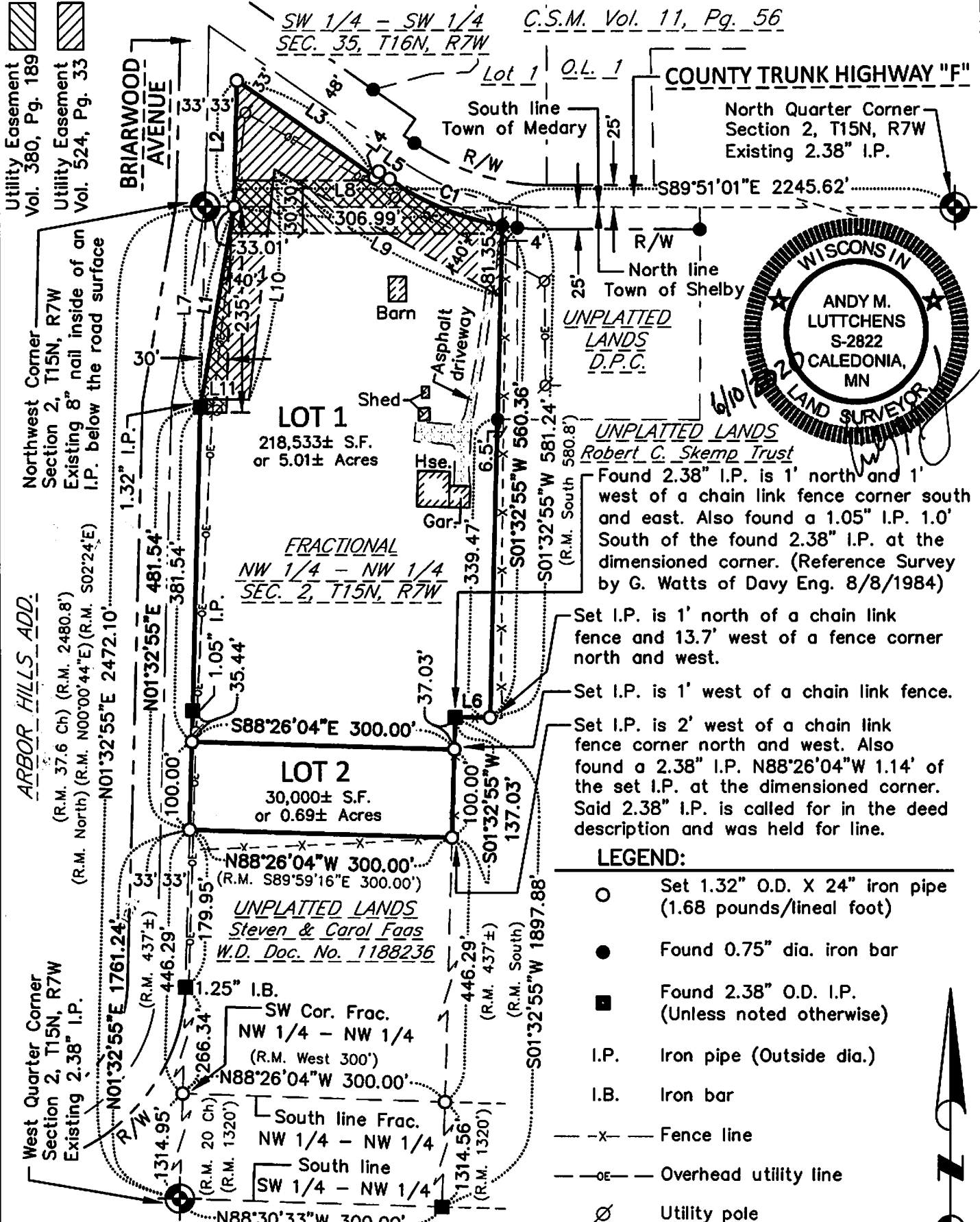


CERTIFIED SURVEY MAP

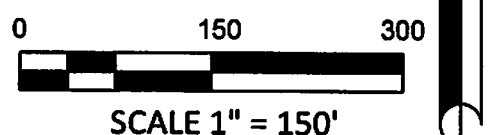


UNPLATTED LANDS

 Found 2.38" I.P. is 1' north and 1' west of a chain link fence corner south and east. Also found a 1.05" I.P. 1.0' South of the found 2.38" I.P. at the dimensioned corner. (Reference Survey by G. Watts of Davy Eng. 8/8/1984)

Set I.P. is 1' north of a chain link fence and 13.7' west of a fence corner north and west.
 Set I.P. is 1' west of a chain link fence.
 Set I.P. is 2' west of a chain link fence corner north and west. Also found a 2.38" I.P. N88°26'04"W 1.14' of the set I.P. at the dimensioned corner. Said 2.38" I.P. is called for in the deed description and was held for line.

DESCRIPTION:

That part of the Fractional Northwest Quarter of the Northwest Quarter of Section 2, Township 15 North, Range 7 West, Town of Shelby and that part of the Southwest Quarter of the Southwest Quarter of Section 35, Township 16 North, Range 7 West, Town of Medary, La Crosse County, Wisconsin, described as follows:

Commencing at the southwest corner of the Northwest Quarter of said Section 2; thence North 01°32'55" East, grid bearing, Wisconsin County Coordinate System, La Crosse County Zone, NAD 83 (1991 Adj.) along the west line of said Northwest Quarter 1761.24 feet to the northwest corner of that certain parcel of land described in Warranty Deed Document No. 1188236, filed for record on January 12, 1998 at the office of the Register of Deeds, La Crosse County, Wisconsin, and the point of beginning, said point also being on the east right-of-way of Briarwood Avenue;

thence continuing North 01°32'55" East along said west line and east right-of-way 481.54 feet; thence North 09°42'33" East along said east right-of-way 232.48 feet to the north line of the Fractional Northwest Quarter of the Northwest Quarter of said Section 2;

thence North 01°32'55" East along said east right-of-way 143.76 feet to the southerly right-of-way of County Trunk Highway "F";

thence South 54°51'01" East along said southerly right-of-way 192.09 feet;

thence South 35°08'59" East along said southerly right-of-way 8.00 feet;

thence South 54°51'01" East along said southerly right-of-way 14.81 feet;

thence Southeasterly along said southerly right-of-way along the arc of a 312.94 foot radius curve, concave Northeast, the chord of which bears South 67°41'52" East and measures 139.17 feet;

thence South 01°32'55" West 560.36 feet;

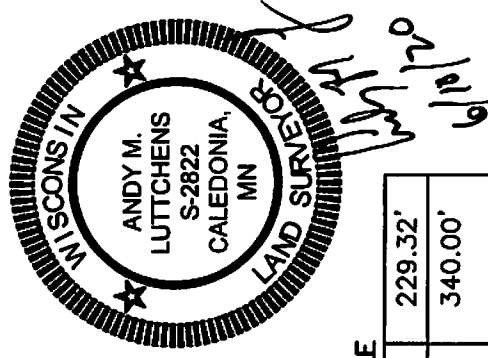
thence North 89°51'01" West 39.91 feet;


