Commencing at the north quarter corner of said Section 29; thence South 89 degrees 36 minutes 51 seconds West, assumed bearing, on the north line of said Northwest Quarter, 396.64 feet; thence South 00 degrees 04 minutes 50 seconds East, 1440.98 feet to the northeast corner of Block 11 of said Mc Connell and Whittlesey's Addition to the Village of North La Crosse, said point being the point of beginning; thence South 00 degrees 04 minutes 50 seconds East on the west line of Kane Street, 350.29 feet to the north line of St. Cloud Street; thence South 82 degrees 16 minutes 41 seconds West on said north line, 154.88 feet to the southwest corner of said Certified Survey Map; thence North 00 degrees 13 minutes 28 seconds West on the west line of said Certified Survey Map and its extension, 370.61 feet to north line of said Block 11; thence North 89 degrees 49 minutes 01 seconds East on said north line, 154.44 feet to the point of beginning.
