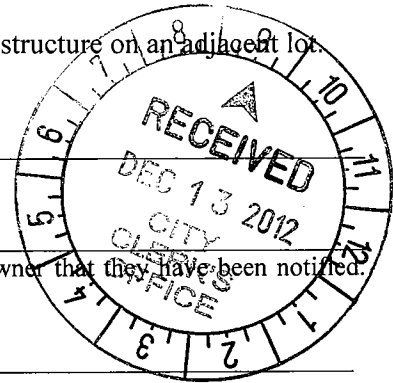

- No enclosure shall be located closer than 25 feet to any residential structure on an adjacent lot.

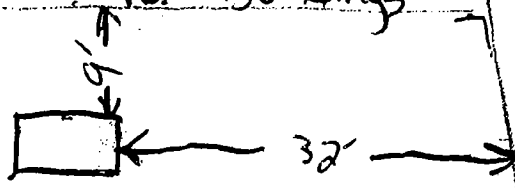

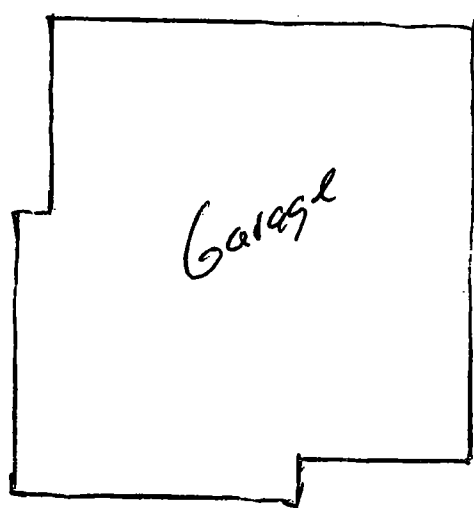
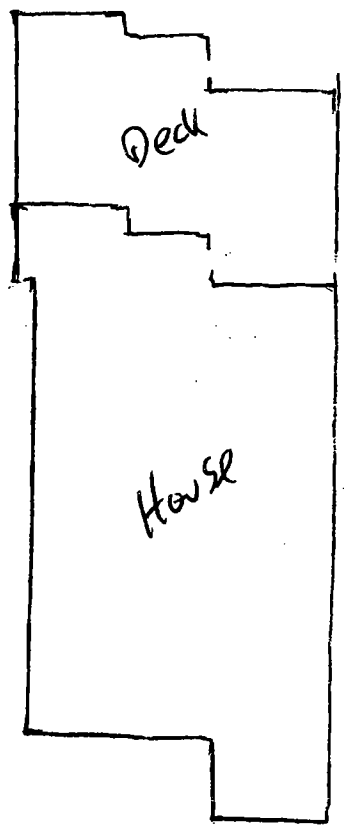
