Subject: AMY & WAYNE DELAGRAVE ANNEXATION

Section 66.0217 (6), Wis. Stats., provides that the annexation of lands to cities and villages within a county having a population of 50,000 or more shall be reviewed by the Department of Administration in order to determine if the proposed annexation is in the public interest or against the public interest. The proposed annexation from the TOWN OF CAMPBELL to the CITY OF LA CROSSE (see attached description) must be reviewed pursuant to the statute.

To assist us in making this determination, we urge that you promptly supply the data requested on the enclosed questionnaire (where possible) and return the questionnaire to the department.

The purpose of this questionnaire is to assist the department in determining "Whether the governmental services, including zoning, to be supplied to the territory could clearly be better supplied by the town...." The statute further stipulates that the department shall study the "shape of the proposed annexation and the homogeneity of the territory with the annexing municipality." In addition, we would appreciate receiving from you any comments or information bearing on governmental services or shape and homogeneity that would indicate whether the annexation is in or against the public interest.

Please return the questionnaire as soon as possible so that the information can be reviewed prior to the department's statutory deadline of September 22, 2016. Direct any questions and comments to Erich Schmidtke at (608) 264-6102. Thank you for your cooperation.



Annexation Description for 1903 Nakomis Avenue

Lot 79 of the Fourth Addition to Hiawatha Islands Addition and part of Government Lot 3 in Section 19, Township 16 North, Range 7 West, La Crosse County, Wisconsin.

Commencing at the North 1/4 Corner of Section 19, Township 16 North, Range 7 West; thence N 89°34' E, 1,632.39' more or less to the Northeast Corner of Outlot 1 of said Fourth Addition; thence S 16°26' E, 276.86'; thence S 4°28' W, 272.53'; thence S 25°22' W, 294.22'; thence S 19°22' W, 216' to the Point of Beginning of this Annexation parcel description, said point also being the Southwest Corner of Lot 58 of said Fourth Addition to Hiawatha Islands Addition;

thence S 89°33' W, 194.91' more or less along the centerline of a 60' wide Right of Way known as Kiowa Place to the Easterly water's edge of a slough running between said Fourth Addition and the Fifth Addition to Hiawatha Islands Addition; thence Northerly along said East Water's edge 101' more or less to its intersection with the North line of said Lot 79; thence along the North line of Lot 79, S 85°03' E, 136.33' more or less to the West Right of Way line of Nakomis Avenue; thence continuing on same bearing 62' more or less to the East Right of Way line of Nakomis Avenue; thence S 19°22' W along said East Right of Way, 115' more or less to the point of beginning.
