**ORDINANCE NO.: 4027**  
AN AMENDED ORDINANCE to delete Section 44-106(b)(2) and to create Section 44-114 of the Code of Ordinances of the City of La Crosse regarding parking restrictions.  
THE COMMON COUNCIL of the City of La Crosse do ordain as follows:  
SECTION I: Section 44-106(b)(2) is hereby deleted and previous Section 44-106(b)(3) is hereby renumbered to 44-106(b)(2).  
SECTION II: Section 44-114 is hereby created to read as follows:  
**Sec. 44-114 Other Parking Restrictions.**  
No person owning or having control of any boat, snowmobile, all-terrain vehicle, camper or a trailer for any of these recreational units, or a utility trailer, shall park such unit unattached from a lawfully registered vehicle on any public street. Unattached utility trailers shall be allowed to park on the street for a maximum of 30 days provided the trailer is parked at an active job site with a building permit issued by the Division of Fire Prevention and Building Safety and the owner of the trailer is clearly identified on the exterior of the trailer. Any vehicle or trailer unlawfully parked under this section may be removed from the street by order of the Chief of Police, and the expense of so moving and storing such vehicle shall be paid by the operator or owner of said vehicle as a forfeiture in addition to the penalties hereafter prescribed.  
SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of the article shall not be affected.  
SECTION IV: This ordinance shall take effect and be in force from and after its passage and publication.
