AN ORDINANCE to amend Sub-section 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Single Family District to the Traditional Neighborhood District - General allowing mixed-use or multi-family at 1222 Denton St.  
THE COMMON COUNCIL of the City of La Crosse do ordain as follows:  
SECTION I: Subsection 115-110 of the Code of Ordinances of the City of La Crosse is hereby amended by transferring certain property from the Single Family District to the Traditional Neighborhood District - General on the Master Zoning Map, to-wit: Tax Parcel No. 17-30048-10. SOUTH SIDE ADDITION LOT 17 BLOCK 8  
SECTION II: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of this division shall not be affected.  
SECTION III: This ordinance shall take effect and be in force from and after its passage and publication.

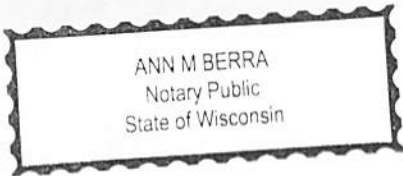
