RESOLUTION

WHEREAS, the public interest requires the vacation of certain streets and alleys within the corporate limits of the City of La Crosse, and

WHEREAS, such vacation should be done as expeditiously as possible,

NOW, THEREFORE, BE IT RESOLVED, by the Common Council, City of La Crosse that it hereby declares that the public interest requires the partial vacation of the alley as described on attached Exhibit "A."

BE IT FURTHER RESOLVED that the portion of the alley above-described be, and the same is hereby ordered vacated, subject, however, to any and all reservations for any and all public and private utilities.

Proposed Alley Vacations

A parcel of land located in the Southeast Quarter of the Northeast Quarter of Section 20, Township 16 North, Range 7 West, City of La Crosse, La Crosse County, Wisconsin. Said Parcel also being in Block 8 of Johnston's Addition abutting Lots 5 and 6 being more particularly described as:

The platted Easterly 10' wide East-West Alley Right of Way lying adjacent to the South lines of Lots 5 and 6 of Block 8 and the platted Easterly 16' wide North-South Alley Right of Way lying adjacent to the East line of Lot 6 of Block 8 including the 16' x 10' more or less wide intersection of the two all of said Block 8 of Johnston's Addition.
