Resolution declaring previously opened public streets as named roadways.

RESOLUTION

WHEREAS, the City of La Crosse has previously obtained or dedicated lands for the opening of public streets; and

WHEREAS, various City and State departments have requested the establishment of names for unnamed roadways in the City of La Crosse for needs related to building and property addressing, directional signage, and emergency response.

BE IT RESOLVED, by the Common Council of the City of La Crosse that in accordance with street-named Ordinances and Section 62.22 of the Wisconsin State Statutes, as well as the City's home rule power, used to establish streets described more fully on the attached exhibits, that such roadways are hereby named, as detailed below.

BE IT FURTHER RESOLVED, that the east-west section of roadway, established west of the STH 16 interchange near Holiday Heights, be named Chestnut Place.

BE IT FURTHER RESOLVED, that the north-south section of roadway, established west of STH 16 and previously accepted by the City of La Crosse as outlot 1, be named Darling Court.

BE IT FURTHER RESOLVED, that the east-west section of roadway, established southwest of Mormon Coulee Road north of N. Marion Rd, be named Ash Lane.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record this resolution with the La Crosse County Register of Deeds.

BE IT FURTHER RESOLVED, that the City Engineer and City Clerk are further authorized to take any and all steps necessary to effectuate this resolution.


