PER MUNICIPAL CODE 103-102 DISCONTINUE ANY DRAINAGE FROM YOU PROPERTY INTO THE PUBLIC ALL AND REOUTE ANY GUTTERS THAT DRAIN TO PUBLIC ALLY OR ASK BOARD OF PUBLIC WORKS FOR PERMISSION TO DRAIN ANY WATER FROM YOUR PROPERTY TO THE PUBLIC ALLEY. A COMPLAINT WAS MADE TO THIS DEPT. OF WATER DRAINING FROM YOUR PROPERTY INTO THE PUBLIC ALLEY. PER MUNICIPAL CODE 103-102 DISCONTINUE ANY DRAINAGE FROM YOU PROPERTY INTO THE PUBLIC ALL AND REOUTE ANY GUTTERS THAT DRAIN TO PUBLIC ALLY OR ASK BOARD OF PUBLIC WORKS FOR PERMISSION TO DRAIN ANY WATER FROM YOUR PROPERTY TO THE PUBLIC ALLEY. Sec. 103-102. - Disposal of water and other liquids. (a) It shall be unlawful to deposit any water or other liquids on public land or to permit such water or liquids to drain over, into or upon the public sidewalks, streets or alleys. The Fire Department - Division of Fire Prevention and Building Safety is authorized to require property owners to connect to the storm sewer when such sewer is available, or to other means of disposal acceptable to the Department, when, in the Department's judgment, the roof area of the building, its proximity to public lands, the amount and density of adjacent surfaces, and other circumstances, will necessitate connection to prevent excessive adverse accumulations of water and ice on the public lands. No water shall be drained to the street gutter except with the written permission of the Department of Public Works.*
