AN ORDINANCE to amend sections 115-207 through 115-282 of the Code of Ordinances of the City of La Crosse regarding Floodplain Zoning, to maintain congruency with the Wisconsin DNR 2012 Model Ordinance.  
THE COMMON COUNCIL of the City of La Crosse do ordain as follows:  
SECTION I: An Ordinance to amend sections 115-207 through 115-282 of the Code of Ordinances of the City of La Crosse regarding Floodplain Zoning, to maintain congruency with the Wisconsin DNR 2012 Model Ordinance, having been placed on file and open to public inspection in the Office of the City Clerk for a period of at least two (2) weeks, commencing April 15, 2016 in accordance with the procedures provided under Section 66.0103, Wis. Stats., is hereby adopted as part of the Code of Ordinances in and for the City of La Crosse, La Crosse County, Wisconsin.  
SECTION II: Except as provided herein, all other provisions of the Code of Ordinances for the City of La Crosse remain unchanged.  
SECTION III: Should any portion of this ordinance be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder of the article shall not be affected.  
SECTION IV: This ordinance shall take effect and be in force from and after its passage and publication.
