AN ORDINANCE to amend Sub-section 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Multiple Dwelling District to the Commercial District.

Property is presently used for: Apartment building.

Property is proposed to be used for: Convenience store with fuel sales and car wash (Kwik Trip).
