

RESOLUTION AUTHORIZING PUBLIC IMPROVEMENT AND LEVYING SPECIAL ASSESSMENTS AGAINST BENEFITED PROPERTY IN

heating were heard.

NOW, THEREFORE, BE IT RESOLVED, the Common Council determines as follows:

It is expedient and necessary and for the best interest of the City of La Crosse and for the property affected thereby, that: improvements be made at the expense of the property benefited, by the construction a sanitary sewer and laterals.
The Council exercises its police

The report of the Board of Public Works, incorporated herein as if fully set forth herein, including the plans and specifications and assessments set forth therein, is adopted and ap-

proved. The Board of Public Works shall advertise for bids and supervise construction of the improvements in accordance with the report hereby adopted and take such other and proper steps to effectuate this reso-

Payment for the improvements shall be made by assessing the entire cost to the property benefited as

tre cost to the property benefited as indicated in the report.

The Council determines that assessments shown on the report represent an exercise of the police power for the health, safety and general welfare of the City and its inhabitants and have been determined as a consequence of the council and the control of the council and the control of the council and th

mined on a reasonable basis and are hereby confirmed.

The due date for the assessments levied against those properties is DEFFERED until a time when either the property owner connects to the new sewer or when the propthe new sewer or when the property is sold or after a period of 10 years; whichever shall occur first, and may be paid in cash or shall be payable over a period of ten years or fifteen years to the City Treasurer. Installments shall be placed on the next tax roll after the due date for collection and shall bear interest at collection and shall bear interest at the rate established by the Council per annum on the unpaid balance from January 1st of the year follow-

The City Clerk shall provide notices in accordance with City Ord. 38-1 Adopted by the Common Council on September 10, 2015.
