NOTICE IS HEREBY GIVEN that the Common Council of the City of La Crosse, by its Judiciary & Administration Committee, will hold a public hearing on a proposed ordinance change in the zoning code as follows:

AN ORDINANCE to amend Sub-section 115-110 of the Code of Ordinances of the City of La Crosse, transferring certain property from the Single Family District to the Residence District allowing duplex at 317 Losey Blvd. S.

Property is presently used for Residential.

Property is proposed to be used for Residential.

Proposed rezoning is necessary because: Non-conforming status of a duplex was lost due to a government seizure, and forced vacancy of the property.

Any person interested may be heard for or against such proposed change, and may appear in person, by attorney or may file a formal objection, which objection forms are available in the City Clerk's Office.

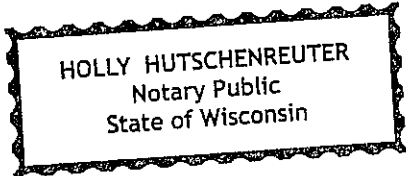
