**Liability**

The client acknowledges that METCO has had no role in the generating, handling, treating, transporting or disposing of hazardous waste which maybe found on the project and is, therefore, not a "covered person" for purposes of CERCLA's 107(a).

Any written documents; including but not limited to reports, plans, assessments, etc.; are prepared for, and for the sole use of, the client and the contents thereof may not be used or relied upon by any person without express written consent and authorization of METCO.

As required by Wisconsin construction lien law, METCO hereby notifies owner that persons or companies furnishing labor or materials for the construction on owner's land may have lien rights on owner's land or buildings if not paid.
