14-1275 Request of Kwik Trip to repave Rublee Street for their new truck entrance up

to Kramer Street.

A motion was made by Swantz, seconded by Seaquist, that this Item be APPROVED pending review and approval by Utilities Manager and staff to ensure there are no significant issues. The motion carried by voice vote.
