What benefit has your organization provided to the La Crosse community, and specifically to the City, in 2024?

The Outdoor Recreation Alliance (ORA Trails) continues to be the primary source of outdoor recreation enhancements, maintenance, and community driven events and programs that fulfill the goal of getting more people outdoors. We work closely with the county, townships, and especially the City of La Crosse to bring project ideas to life, build and maintain trails located on city property (Upper Hixon, Lower Hixon, The Gateway Trails on Grandad Bluff) and assist with maintenance, restoration, and enhancements throughout all of the City owned Bluffland Properties. ORA utilizes our strong volunteer base to complete regular maintenance, and pays for a seasonal staff base for the last 4 summers to solely maintain trails and keep invasives at bay on City owned properties. ORA has donated multiple recreation structures to the city including the Bike Skills Area at Lueth Park, Universal Treehouse at Chad Erickson Park, The nature loop off of Bud Hendrickson Trail, and more. We bring value to our partnership with the City by continuing to be the trusted source for keeping our trails and recreation areas in great shape, attracting tourists and providing daily activity spaces for community members.

No. We've received a county bluffland grant award in 2024 and 2023. We've also received a Knowles Nelson grant award for a different project, and a few smaller grant awards for specific projects in the past. In 2021 we received a \$50k operational grant from the LCF.

We will use the funds to support staff wages, and training and equipment costs.

We are the sole group that maintains and enhances trails on City properties. Without the work of our group, trails would overgrow and become unusable within months. We work hard year round to preserve one of the City's finest assets! Trails are free for all to use, and have very minimal barriers to use. To lose them would affect every person who lives here, and most who visit our area.

Because trails are a free asset, there are no formal tracking methods used, alongside the City, we've utilized trail cameras and trail counters to estimate the number of users. The results are stunning. Hundreds of people pass by these markers weekly and that usage has continued to increase as we add more trails and enhance the current trails.
