

ORDINANCE NO. 5196

AN ORDINANCE to repeal and recreate Section 2-31(b) of the Code of Ordinances of the City of La Crosse establishing boundaries for aldermanic districts.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

SECTION I: Section 2-31 (b) is hereby repealed and recreated to read as follows:

(b) Boundaries. The Aldermanic Districts shall be numbered and bounded as set forth below. A map showing such districts is one file in the office of the City Engineer.

(1) FIRST DISTRICT.

North – City Limits.

East – Intersection of City Limits and Interstate 90; West on Interstate 90 to the westerly spur track of the Burlington Northern Railroad; south along the westerly spur track of the Burlington Northern Railroad to Gohres Street extended East to the said spur track.

West – City limits.

South – Intersection of Gohres Street extended East and Westerly spur track of the Burlington Northern Railroad; West on Gohres Street and Gohres Street extended to Liberty Street; South on Liberty Street to Sill Street; west on Sill Street to Avon Street; South on Avon Street to Clinton Street; West on Clinton Street to the West City Limits.

(2) SECOND DISTRICT.

North – City limits.

East – City limits.

West – Intersection of City Limits and Interstate 90; West on Interstate 90 to the Westerly spur track of the Burlington Northern Railroad; Southerly on spur track of the Burlington Northern Railroad to Gohres Street extended East to the spur track; West on Gohres Street extended and Gohres Street to Liberty Street; south on Liberty Street to Sill Street; west on Sill Street to Avon Street; South on Avon Street to Clinton Street; West on Clinton Street to City Limits; South on City limits to CP Railroad.

South – Intersection of City limits and CP Railroad; East along CP Railroad to Copeland Avenue; South on Copeland Avenue to Gould Street; East on Gould Street to Rose Street; North on Rose Street to CP Railroad; East on CP Railroad to Gillette Street; East on Gillette Street to City Limits.

- (3) THIRD DISTRICT.  
North – Intersection of City limits and CP Railroad; East along CP Railroad to Copeland Avenue; South on Copeland Avenue to Gould Street; East on Gould Street to Rose Street; North on Rose Street to CP Railroad; East on CP Railroad to Gillette Street; East on Gillette Street to City Limits.  
East – City limits.  
West – City limits.  
South – Beginning at Intersection of City limits and center of the main channel of the Mississippi River; Thence South along said Mississippi River to the extended West centerline of the La Crosse River; East along La Crosse River extended and the La Crosse River to 3<sup>rd</sup> Street; South on 3<sup>rd</sup> Street to La Crosse Street; East on La Crosse Street to State Highway “16”; North on State Highway “16” to City Limits.
- (4) FOURTH DISTRICT.  
North – City limits.  
East – City limits.  
West – State Highway “16” and City Limits; South on State Highway “16” to La Crosse Street; West on La Crosse Street to Campbell Road; South on Campbell Road to State Street; West on State Street to 16<sup>th</sup> Street; North on 16<sup>th</sup> Street to Vine Street; West on Vine Street to 13<sup>th</sup> Street; North on 13<sup>th</sup> Street to Pine Street; West on Pine Street to West Avenue; South on West Avenue to Madison Street.  
South –West Avenue and Madison Street; East on Madison Street to 17<sup>th</sup> Street; North on 17<sup>th</sup> Street to Cameron Avenue; East on Cameron Avenue to 19<sup>th</sup> Street; North on 19<sup>th</sup> Street to Cass Street; East on Cass Street to City Limits.
- (5) FIFTH DISTRICT.  
North – La Crosse Street.  
East – Campbell Road.  
West – West Avenue.  
South – Intersection of West Avenue and Pine Street; East on Pine Street to 13<sup>th</sup> Street; South on 13<sup>th</sup> Street to Vine Street; East on Vine Street to 16<sup>th</sup> Street; South on 16<sup>th</sup> Street to State Street; East on State Street to Campbell Road.
- (6) SIXTH DISTRICT.  
North – Intersection of the Main channel of the Mississippi River and the City Limits; Southeast along the Main Channel of the Mississippi River to the extended Westerly centerline of the La Crosse River; East along the La Crosse River extended and the La Crosse River to 3<sup>rd</sup> Street; South on 3<sup>rd</sup> Street to La Crosse Street; East on La Crosse Street to West Avenue.  
East – West Avenue.  
West – City Limits.  
South –Intersection of City Limits and U.S. Highway “14/61”; East on U.S. Highway “14/61” to Cass Street; East on Cass Street to 9<sup>th</sup> Street; North on 9<sup>th</sup> Street to King Street; East on King Street to West Avenue.

- (7) SEVENTH DISTRICT.  
North – Intersection of 17<sup>th</sup> Street and Cameron Avenue; East on Cameron Avenue to 19<sup>th</sup> Street; North on 19<sup>th</sup> Street to Cass Street; East on Cass Street to City Limits.  
East – City limits.  
West – Intersection of 17<sup>th</sup> Street and Cameron Avenue; South on 17<sup>th</sup> Street to Jackson Street; East on Jackson Street to State Road.  
South – State Road.
- (8) EIGHTH DISTRICT.  
North – Intersection of Cass Street and 8<sup>th</sup> Street; East on Cass Street to 9<sup>th</sup> Street; North on 9<sup>th</sup> Street to King Street; East on King Street to West Avenue; South on West Avenue to Madison Street; East on Madison Street to 17<sup>th</sup> Street.  
East – Intersection of 17<sup>th</sup> Street and Madison Street; South on 17<sup>th</sup> Street to Jackson Street; East on Jackson Street to East Avenue; South on East Avenue to Farnam Street.  
West – 8<sup>th</sup> Street.  
South – Farnam Street.
- (9) NINTH DISTRICT.  
North – U.S. Highway “14/61” from the West City Limits East to Cass Street; East on Cass Street to 8<sup>th</sup> Street.  
East – Intersection of 8<sup>th</sup> Street and Cass Street; South on 8<sup>th</sup> Street to Farnam Street; West on Farnam Street to 7<sup>th</sup> Street; South on 7<sup>th</sup> Street to South Avenue.  
West – City limits.  
South – Intersection of West City Limits and East bank of Coleman Slough; North along East bank of Coleman Slough to North Bank of Swift Creek; East along North bank of Swift Creek to Maple Street; East on Maple Street to West Avenue; North on West Avenue to South Avenue; Northwest on South Avenue to 7<sup>th</sup> Street.
- (10) TENTH DISTRICT.  
North –Intersection of South Avenue and 7<sup>th</sup> Street; North on 7<sup>th</sup> Street to Farnam Street; East on Farnam Street to East Avenue; North on East Avenue to Jackson Street; East on Jackson Street to State Road; East on State Road to Losey Boulevard.  
East –Losey Boulevard.  
West –South Avenue.  
South – Intersection of South Avenue and 13<sup>th</sup> Street; North on 13<sup>th</sup> Street to Weston Street; East on Weston Street to Losey Boulevard.

- (11) ELEVENTH DISTRICT.  
North – Intersection of West City Limits and East bank of Coleman Slough; North along East bank of Coleman Slough to North Bank of Swift Creek; East along North bank of Swift Creek to Maple Street; East on Maple Street to West Avenue; North on West Avenue to South Avenue; South on South Avenue to 13<sup>th</sup> Street; North on 13<sup>th</sup> Street to Weston Street; East on Weston Street to Losey Boulevard.  
East – Intersection of Weston Street and Losey Boulevard; South on Losey Boulevard to City Limits; West on Ward Avenue along said City Limits; South on City Limits to Intersection of Diagonal Road and 27<sup>th</sup> Street; South on 27<sup>th</sup> Street to Birch Street; East on Birch Street to 28<sup>th</sup> Street; South on 28<sup>th</sup> Street to Mesa Grande Place; East on Mesa Grande Place to Church Court; South on Church Court to Broadview Place; West on Broadview Place to Intersection of Mormon Coulee Road; West to the intersection of the West line of Mormon Coulee Road and the North line of Shelby Road; West on North line of Shelby Road to its intersection of the extended Northerly – West line of Tax Parcel ID 17-50470-50 (2616 Shelby Road); thence South along said West line to its intersection with the City Limits.  
West –City Limits.  
South – City limits.
- (12) TWELFTH DISTRICT.  
North – State Road.  
East – City limits.  
West – Intersection of State Road and Losey Boulevard; South on Losey Boulevard to Ward Avenue and City Limits; East on City Limits to Intersection of Diagonal Road and 27<sup>th</sup> Street; South on 27<sup>th</sup> Street to Birch Street; East on Birch Street to 28<sup>th</sup> Street; South on 28<sup>th</sup> Street to Mesa Grande Place; East on Mesa Grande Place to Church Court; South on Church Court to Broadview Place;  
South – Intersection of Church Court and Broadview Place; East on Broadview Place to 33<sup>rd</sup> Street; North on 33<sup>rd</sup> Street to Robinsdale Avenue; East on Robinsdale Avenue to Elm Drive; North on Elm Drive to Easter Road; East on Easter Road to City Limits.
- (13) THIRTEENTH DISTRICT.  
North – Intersection City Limits and Easter Road; West on Easter Road to Elm Drive; South on Elm Drive to Robinsdale Avenue; West on Robinsdale Avenue to 33<sup>rd</sup> Street; South on 33<sup>rd</sup> Street to Broadview Place; West on Broadview Place to Mormon Coulee Road; West to the intersection of the West line of Mormon Coulee Road and the North line of Shelby Road; West on North line of Shelby Road to its intersection of the extended Northerly – West line of Tax Parcel ID 17-50470-50 (2616 Shelby Road); thence South along said West line to its intersection with the City Limits.  
East – City limits.  
West – City limits.  
South – City limits.

SECTION II: This ordinance shall take effect upon its passage and publication.
