I, RICHARD A. BERG PROFESSIONAL LAND SURVEYOR, HEREBY CERTFY THAT I HAVE SURVEYED AND MAPPED THIS CERTIFIED SURVEY OF PART OF THE SW1/4 OF THE NE1/4 OF SECTION 12, T15N, R7W, TOWN OF SHELBY, LACROSSE COUNTY WISCONSIN, DESCRIBED AS FOLLOWS: COMMENCING AT THE EAST QUARTER CORNER OF SECTION 12, T15N, R7W; THENCE N89°36'27"W, 2603.52 FEET TO THE CENTER OF SAID SECTION 12; THENCE N88°31'44"E, 811.86 FEET, TO A POINT ON THE NORTH RIGHT-OF-WAY LINE OF KNOBLOCH ROAD, AND THE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE N14°43'51"E, 177.64 FEET; THENCE S89°41'39"E, 404.25 FEET, TO THE WEST RIGHT-OF-WAY LINE OF KNOBLOCH ROAD; THENCE S00°00'13"W, 132.33 FEET ALONG SAID RIGHT-OF-WAY LINE; THENCE SOUTHWESTERLY ALONG THE NORTHWESTERLY RIGHT-OF-WAY LINE OF KNOBLOCH ROAD, 62.25 FEET ALONG THE ARC OF A 39.50 FOOT RADIUS CURVE, CONCAVE TO THE NORTHWEST, THE CHORD OF WHICH BEARS S45°09'17"W, AND MEASURES 56.01 FEET; THENCE N89°41'39"W, 409.70 FEET ALONG THE NORTH RIGHT-OF-WAY LINE OF KNOBLOCH ROAD, TO THE POINT OF BEGINNING OF THIS DESCRIPTION.

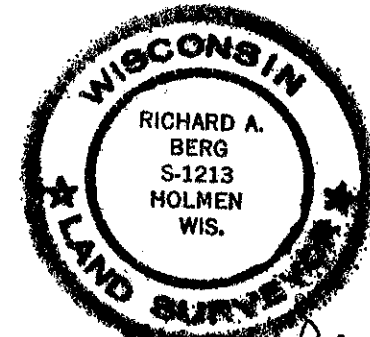
