3.	<u>16-0275</u>	AN ORDINANCE to annex parcels of land from the Town of Campbell to the City of La Crosse (City of La Crosse owned parcel at 608 Dakota Street).

4. 16-0362 Application of Joan + Jay LLC (Joan Ferris and Jerry Sparks) for a Conditional Use Permit at 300 3rd St. S. allowing for a Combination "Class B" Beer & Liquor License and resolution approving same.

8.	<u>16-0471</u>	AN ORDINANCE to create Section 115-347(7) of the Code of Ordinances of the City of La Crosse allowing for general garages for minor automobile repair services in the C1-Local Business zoning district by a Conditional Use Permit.
		James Cherf moved to approve the Ordinance. Richard Becker seconded. The motion passed 7-0.
9.	<u>16-0482</u>	Application of Jansen Dahl dba Automotive Enterprises LLC for a Conditional Use Permit at 410 and 414 Division Street allowing demolition of single family homes for landscaped parking area.
		Ryan Cornett moved to approve the application with the following recommendations:  1) Applicant shall reduce number of curb cuts on the overall site to one on each adjacent street and is encouraged to reorient parking to use the adjacent alley way for access. 2) Applicant shall create a buffer or curb along the entire sidewalk to prevent cars from driving over it. 3) Both parcels shall be requested to be combined into 400 Division Street at the same time a Demolition Permit is applied for. Elaine Yager seconded. The motion passed 5-2. (Turtenwald, Schoenfeld voting no)

AN ORDINANCE to amend Section 115-110 of the Code of Ordinances of the City of La Crosse by transferring certain property from the Single Family District to the Local Business District at 1221 Caledonia Street allowing for lower commercial space and upper residential space.

AN AMENDED ORDINANCE to amend Subsection 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Planned Development District - General to the Planned Development District - General allowing for a mixed use with residential duplexes and townhomes at Park Plaza Dr. and 529, 601, 611 and 621 Park Plaza Dr.

James Cherf moved to approve the Ordinance with the request that the proposed street will remain a private street. Richard Becker seconded. The motion passed 6-1. (Turtenwald voting no)

Preliminary Plat of The Quarry at Irish Hill to the Town of Shelby, Wisconsin and resolution approving same.

James Cherf moved to approve the preliminary plat with waivers of the City's platting requirements and with the following conditions: 1) The access must comply with NFPA 1 Chapter 18 regarding fire department access and water supply. 2) NFPA 1141 Fire Protection Infrastructure for Land Development in Wildland, Rural, and Suburban areas must be followed. Ryan Cornett seconded. The motion passed 5-2. (Schoenfeld, Kabat voting no)

Preliminary Plat (reapplication) of Maple Ridge Addition to the Town of Medary, Wisconsin and resolution approving same.

Ryan Cornett moved to approve the preliminary plat with the following conditions: 1) The developer provide a fiscal impact analysis of the development to the County. 2) The development be evaluated to prevent "skylining". 3) The area surrounding the development be evaluated, targeting the 1 per 35 recommendation, preserving lands around the development toward conservation development and low density rural development patterns. Richard Becker seconded. The motion passed 5-2. (Schoenfeld, Kabat voting no)
