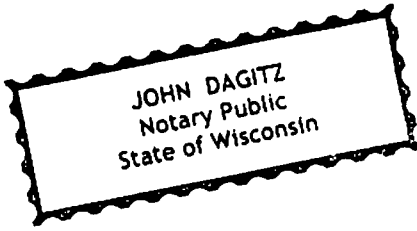

ORDINANCE NO.: 5226

AN AMENDED ORDINANCE to amend Subsection 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Planned Development District - General - to the Planned Development District - Specific allowing for mixed use redevelopment at 2415 State Road.

THE COMMON COUNCIL of the City of La Crosse do ordain as follows:

SECTION I: Subsection 115-110 of the Code of Ordinances of the City of La Crosse is hereby amended by transferring certain property from the Planned Development District - General - to the Planned Development District - Specific, to-wit:

Tax Parcel 17-50298-32

SECTION II: Said rezoning is approved based on the amended plans dated 6/17/2022, contingent on final review and completion of design review process, to be signed off on by the planning Administrator.

SECTION IV: This ordinance shall take effect and be in force from and after its passage and publication.
