

Amended Resolution creating Wards 27 and 28.

AMENDED RESOLUTION

WHEREAS, Section 5.15(6)(a), Wis. Stats., provides that no ward line may cross the boundaries of a congressional, assembly or supervisory district; and

WHEREAS, two properties known as Meyer - Sunset Court and Konichek - 2602 Shelby Road were annexed from the Towns of Medary and Shelby and they cross district boundaries; and

~~WHEREAS, the Meyer - Sunset Court property crosses into the 28th Supervisory District where adjacent properties in the City limits are within the 2nd Supervisory District.~~

~~WHEREAS, the Konichek - 2602 Shelby Road property crosses into the 96th Assembly District and 30th Supervisory District where adjacent properties in the City limits are within the 95th Assembly District and 11th Supervisory District a separate ward must be created for each annexation for election administration; and~~

WHEREAS, Section 5.40(3)(a), Wis. Stats. provides that the municipality may elect to utilize paper ballots instead of voting machines, so long as the number of electors residing in the territory does not exceed 100.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of La Crosse that this Council's previous resolution adopted October 14, 2021 be and the same is hereby amended to provide for the creation of wards 27 and 28 due to the annexation of two properties as depicted on Exhibits A and B.

Meyer – Sunset Court	Ward 27	2 nd Aldermanic District
Konichek – 2602 Shelby Road	Ward 28	11 th Aldermanic District

BE IT FURTHER RESOLVED that except as otherwise amended, the aforesaid Council resolution establishing various wards within the City of La Crosse be and the same is in full force and effect.


BE IT FURTHER RESOLVED that the wards shall be assigned to the following polling places for the City of La Crosse to facilitate using a common polling place:

27 th Ward	Harry J Olson Senior Citizen Center, 1607 North St.
28 th Ward	Living Word Christian Church, 2015 Ward Ave.

BE IT FURTHER RESOLVED by the Common Council of the City of La Crosse that the use of paper ballots is hereby authorized for these wards at the discretion of the City Clerk.

BE IT FURTHER RESOLVED that upon adoption of this resolution, the City Clerk is authorized to send a copy of same to the La Crosse County Clerk and the Legislative Reference Bureau in accordance with Wis. Stat., sec. 5.15(4)(b).
