Action required - DRIFT La Crosse Community Bike Share Committee is requesting \$7500 in BPAC funding for the installation of concrete pads to accommodate bike share docks/racks. Three locations are proposed: 410 E Veterans Memorial Dr, 308 Front St South, 105 King St

Currently scoped as pavement replacement of 3rd and 4th, from Cass Street northerly to the 2nd Street Intersection, scheduled for construction in 2026-2028. Not yet determined if it will cover curb-to curb or building face to building face.

Staff has begun outreach to consultants to create conceptual illustrations of a rebuilt 3rd and 4th Streets. Can the committee provide what type of treatments they would like to see in the conceptual plans? For example treatment options; expanded 20-25 foot sidewalks, streets trees, benches, planters, bike lanes, separated bike lanes, curb extensions, two-way traffic?
