RESOLUTION AUTHORIZING PUBLIC IMPROVEMENT AND LEVYING SPECIAL ASSESSMENTS AGAINST BENEFITED PROPERTY IN LA CROSSE, WISCONSIN.
RESOLUTION

WHEREAS, on July 10th, 2017, a report was prepared and adopted by the Board of Public Works on the proposed public improvements consisting of the construction of Water main and all appurtenances on 17th Street Jackson Street and Winnebago as well as between Market Street and Ferry Street and assessments against benefited properties, and said report is currently on file with the City Clerk, and

WHEREAS, on August 3rd, 2017, the Finance and Personnel Committee of La Crosse, Wisconsin will hold a public hearing for all interested persons concerning the report of the Board of Public Works, this resolution and proposed assessments against benefited property, and all persons who desired to speak at the hearing were heard.

NOW, THEREFORE, BE IT RESOLVED, the Common Council determines as follows:

It is expedient and necessary and for the best interest of the City of La Crosse and for the property affected thereby, that the utilities on 17th Street between Jackson Street and Winnebago as well as between Market Street and Ferry Street be improved at the expense of the property benefited by the construction of Water main and all appurtenances.

The Common Council exercises its police power to levy special assessments upon property for benefits conferred upon such property.

The report of the Board of Public Works, incorporated herein as it fully set forth herein, including plans and specifications and assessments set forth therein, is adopted and approved.

The Board of Public Works shall advertise for bids and supervise construction of the improvements in accordance with the report hereby adopted and take such other and proper steps to effectuate this resolution.

Payment for the improvements shall be made by assessing the entire cost to the property benefited as indicated in the report.

The Common Council determines that assessments shown on the re-
