

Resolution amending Appendix C Fee Schedule to increase various fees as a result of charges incurred to the Police Department in conducting background checks.

### RESOLUTION

WHEREAS, the Common Council approved Resolution File #17-0680 on July 13, 2017, authorizing the Police Department to receive reimbursement from the City General Fund for unanticipated fees incurred for criminal background checks for fiscal year 2017, and

WHEREAS, said background checks are required by state and local law to be conducted prior to issuance of certain licenses and will be required beyond fiscal year 2017.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of La Crosse that it hereby approves the following changes to Appendix C to increase various fees as a result of charges incurred to the Police Department in conducting background checks.


BE IT FURTHER RESOLVED that all other fees included within Appendix C remain unchanged.
