

**NOTICE OF HEARING ON
AMENDMENT TO ZONING RESTRICTION**

TO WHOM IT MAY CONCERN:

NOTICE IS HEREBY GIVEN that the Common Council of the City of La Crosse by its Judiciary and Administration Committee will hold a public hearing upon the proposed change in the zoning ordinance hereinafter set forth. Such public hearing will be held at **7:30 p.m. on Tuesday, July 2, 2013** in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.

The City Plan Commission of the City of La Crosse will meet to consider such ordinance on **Monday, July 1, 2013 at 4:00 p.m.** in the 3rd Floor Conference Room in City Hall, the Committee of the Whole on **Tuesday, July 9, 2013 at 7:30 p.m.** and final action will be determined by the Common Council on **Thursday, July 11, 2013 at 7:30 p.m.**, both in the Council Chambers in the City Hall in the City of La Crosse, La Crosse County, Wisconsin.

Any person interested may be heard for or against such proposed change, and may appear in person, by attorney or may file a formal objection, which objection forms are available in the Office of the City Clerk.

Such proposed change set forth in the ordinance now pending before the Common Council of the City of La Crosse is as follows:

AN ORDINANCE to amend Section 15.02(B) of the Code of Ordinance of the City of La Crosse by transferring certain property from the Planned Development District – Specific to the Planned Development District – Specific

allowing for development of additional 2-story building containing 20 apartments and waiver of multi-family design standards (Bluffview Apartments).

Said property is generally located at **3715 Mormon Coulee Rd. (17-50319-60)**, which contains approximately .259 acres and is further described as follows:
