TO: Lawn Mowing Contractors

SUBJECT: Request for Quotations (RFQ) – Contracted Mowing Services

Various departments, of the City of La Crosse Wisconsin, are accepting quotations for lawn maintenance at multiple sites/facilities as listed on the attached summaries. Each location shall be mowed as indicated on the attached Site Summaries, or as directed by the department responsible for the site. At a minimum, work at each site shall include:

1. Mowing per the requirements of the site list(s); grass shall be mowed to a finished length of approximately 3".
2. Mowing boulevards at all sites where applicable;
3. Trimming along sidewalk edges curb lines and around all buildings, structures, fences, sign poles, trees, hydrants and similar features **following each mowing**;
4. Cleaning cuttings from sidewalks;
5. Mulching cuttings or directing them away from City streets and cleaning gutter areas after mowing;
6. Collecting and disposing of garbage found in the mowing areas.

In order to allow watering at these locations, contractor(s) should try to schedule and complete mowing work on Mondays, Wednesdays and Fridays between the hours of 8:00 AM and 7:00 PM. Actual mowing schedules should be coordinated with responsible departments. Weekend mowing is not allowed in City parks. General information:

- Appropriate Personal Protective Equipment (PPE) shall be used by Contractors and Contractors' employees at all times while mowing.
- Grassed islands on West Avenue are included with this request for mowing services. While working in these areas, contractor(s) and their employees shall wear reflective vests or other high visibility clothing that satisfies current ANSI Class 2 standards.
- For purposes of this work, unless otherwise specified, mowing along bike/pedestrian trails shall be the width of one mower pass or a minimum of 36" wide.
- Mowing frequency may be increased or decreased on a site-by-site basis during the course of the summer.
- It may be necessary to request the contractor(s) to mow additional sites during the mowing season. The responsible department will negotiate directly with the specific contractor for the additional cost per mowing to include these sites.
- Park Department will require contractor(s) to complete mowing work to avoid events at park locations, and will provide contractor(s) event schedules for each location.
- For all sites, before the first mowing of the season, contractors shall go through the sites and pick-up debris and branches left over from the winter. Larger tree limbs should be reported for pick-up by Park Department crews.
- The Park Department is accepting, as an option to mowing operations, quotes to perform weed control via spraying at various locations. Liquid weed control must be pet friendly and sustainable.
- Park Department staff, or a contracted third-party vendor, will inspect contracted sites to insure contract compliance with mowing/trimming/cleaning as stated above. Infractions will be documented and communicated to Contractor. After three (3) documented infractions, the Park Department will review contractor performance and at its sole discretion reserves the right to terminate contract with no discussion or recourse.
- Vendors wishing to provide quotations on mowing contracts shall complete the provided SIGNATURE SHEET with submitted quotes.

Quotations shall reflect the cost of mowing each site group per mowing. Attached are:

- **Quotation forms for North and South site group lists.** Mowing contractors may submit quotations for any or all of the site group lists. Quotations must be for the full list of sites as shown on each Site Summary. Incomplete Quotation forms will be rejected.
- **Quotation forms for Park Department North, South, and Misc site group lists,** separated into small and large site groups. Mowing contractors may submit quotations for any or all of the site group lists. Quotations must be for the full list of site group(s) as shown on each Quotation form. Incomplete quotation forms will be rejected.
- Contractors may not quote on individual sites from any list. Incomplete quotation forms will be rejected. **EXAMPLE: A contractor may submit quotations on the full list of North and South small site groups but choose not to quote the large site groups. Quotations will be evaluated based on full list totals and RFI FORM review to determine a responsible vendor.** The City of La Crosse reserves the right to accept or reject any or all quotations and RFI FORM or any part thereof, or portion of, the quotations and RFI FORM, to waive any technicality in any quotations and RFI FORM submitted, and to accept any part of a quotation and RFI FORM as deemed to be in the best interests of the City of La Crosse. The City of La Crosse, at its sole discretion, reserves the right to choose multiple, responsible, contractors to complete work at the various sites described on the mowing lists.

The awarded mowing contractor(s) will be required to sign a contract with the City for this work. A sample of the contract, including the City's Standard Terms & Conditions that apply to this work, is enclosed with this request for mowing services. Contractors are specifically referred to Wisconsin Administrative Code 270.13(15) (b) which describes minimum age requirements for workers performing this work for the City. **The intent of this RFQ is to award an initial one-year contract or contracts that may be extended up to five (5) one-year contracts based on review of contractors' performance during the contract period at the sole discretion of the City of La Crosse.**

Monthly payments for mowing services will be made for bills received by the 25th of each month. Contractor(s) shall send separate invoices for mowing work related to Wastewater, Water, Storm Water, Planning, Grounds & Buildings, Streets and Parks sites, as shown on the Quotation Forms, directly to those departments. Invoices for mowing work shall include:

- Full business name & address
- Business contact person
- Unique Invoice number and Invoice date

Following award of contracts, the successful contractor(s) information will be provided for direct contact to city staff responsible for management of sites within their departments.

In selection a responsible vendor, the City of La Crosse reserves the right to accept or reject any or all quotations and RFI FORM or any part thereof, or portion of, the quotations and RFI FORM, to waive any technicality in any quotations and RFI FORM submitted, and to accept any part of a quotation and RFI FORM as deemed to be in the best interests of the City of La Crosse. The City of La Crosse, at its sole discretion, reserves the right to choose multiple, responsible, contractors to complete work at the various sites described on the mowing lists.
