AN AMENDED ORDINANCE to amend the Parking Violation Table in Section 44-1 of the Code of Ordinances of the City of La Crosse regarding City lots and ramps.  
THE COMMON COUNCIL of the City of La Crosse do ordain as follows:  
SECTION I: The Parking Violation Table located within Section 44-1 is hereby amended to read as follows:
