

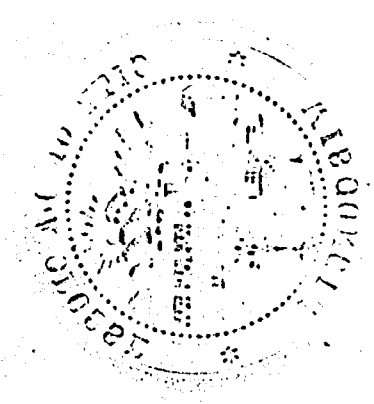

WHEREAS, the public interest requires the vacation of certain streets and alleys within the corporate limits of the City of La Crosse,

WHEREAS, such vacation should be done as expeditiously as possible,

NOW, THEREFORE, BE IT RESOLVED, by the Common Council of the City of La Crosse that it hereby declares that the public interest requires the vacation of the entire remainder of Shiftar Road which is described on attached Exhibit "A".

BE IT FURTHER RESOLVED that the portion of the street above-described be, and the same is hereby ordered vacated, subject, however, to reservations provided by law for public and private utilities.

Shiflar Road Vacation

A parcel of land being located in the SE ¼ of the NW ¼ of Section 21, Township 16 North, Range 7 West, City of La Crosse, La Crosse County, Wisconsin more particularly described as follows:

That part of Shiflar Road lying between the following parcels:

Bordering on the Southwest of the proposed vacation of Shiflar Road is the East line of a 60' wide Right of Way known as Elm Drive and the Northerly line of the former 40' Wide Right of Way line of Park Lane now known as the North line of Elm Drive.

Bordering on the Northeast of the proposed vacation of Shiflar Road is the Northwesterly prolongation of the southwesterly line of the lands described in Volume 724, Page 454 referenced in Document Number 1620305 of County Records.
