Richard Becker moved to refer this item for 30 days. James Cherf seconded. The motion passed 5-0. Richard Becker moved for a reconsideration of the item. James Cherf seconded. The motion passed 5-0. Richard Becker moved to approve subject to approval of the Planning Department, Engineering Department, and Fire Department and a waiver of the platting requirements. Scott Neumeister seconded. The motion failed 2-3. Mayor Tim Kabat, James Cherf, and Randy Turtenwald voting no. Richard Becker moved to refer this item for 30 days. James Cherf seconded. The motion passed 5-0.

11. <u>15-0476</u>

Review of plans for the proposed site improvements of the property and exterior renovations of the building located at 2135 Enterprise Avenue.

Richard Becker moved to approve the plans with the following conditions:

- 1) Fencing for storage must include 75% screening slats.
- 2) Only visitor or employee parking be allowed in the side yard parking area.
- 3) A driveway.sidewalk permit be obtained for the new curb cut.
