The purpose of the meeting is to organize the Joint Review Board for further consideration of the City's proposal to amend Tax Incremental District No. 10.

The hearing will be held to provide the public a reasonable opportunity to comment on the proposed amendments to the Project Plan for Tax Incremental District No. 10.

Based on the condition of properties within its boundaries at time of creation, territory within the District was previously identified as a blighted area.

Projects to be undertaken within the District and costs to be incurred (Project Costs) will continue to be for the purpose of eliminating or reducing blight and may include acquisition of property, rights of way or easements, site preparation, installation or rehabilitation of utilities and streets, payment of cash grants as development incentives to owners, lessees, or developers of land located within the District, professional services and organizational costs, administrative costs, financing costs and other costs as may be necessary to implement the District's Project Plan. Projects may be undertaken within the District's proposed boundary and in areas located in the City within 1/4 mile of that boundary.

As permitted under Wisconsin Statutes Section 66.1105(4)(h)1., the list of estimated Project Costs in the current Project Plan would be amended and increased by approximately \$2,000,000.

All interested parties will be given a reasonable opportunity to comment on the proposed amendments to the District's Project Plan. A copy of the proposed amendment to the District's Project Plan is available for public inspection and will be provided on request during normal business hours at the office of the City Clerk at the La Crosse City Hall, located at 400 La Crosse Street.
