Don makes a motion to approve with the condition that the county do a water shed study, and consider a water catchment system on the corner of Trudy's property near the corner of Fox Hollow Drive and County O. Bob seconds. Motion passed."

A certified survey map was just submitted to our office for property owned by Trudy Miller (parcel 2-355-0). Per City code, certified survey maps for property within the City's extraterritorial jurisdiction must be reviewed by the City prior to recording with the Register of Deeds. The CSMs must also have Town and County approval prior to submitting to the City.

The applicant has noted that the Barre Town Board approved on June 9, 2026; however, the certified survey map that was provided was not signed by the Town of Barre. I saw that the Planning Commission approved, but I just want to confirm that it was also approved by the Town Board. Attached is their map, for reference.
