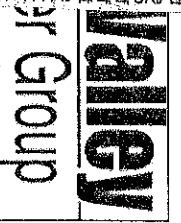

Notice is hereby given that at a regular meeting of the Common Council of the City of La Crosse held in the Council Chambers in City Hall in said City at 6:00 o'clock in the evening of August 9, 2018 notice duly given, the said Common Council received a final determination as to the amount of damages that will accrue to each parcel of real estate in the City of La Crosse, Wisconsin. Beginning at the intersection of the North line of Cass Street and the Eastern bank of the Mississippi River: Thence east along the North line of Cass Street to the West line of 6th Street; Thence north along the West line of 6th Street to the North line of King Street; Thence east along the North line of King Street; Thence north-south valley between 6th Street and 7th Street; Thence north along

the West line of said north-south alley to South line of Lot 15 of Block 4 of Burns and Overbaugh; Addition; Thence east along said South line of Lot 15 to the East line of 6th Street; Thence north along said Eastern line of 6th Street to the North line of Main Street; Thence east along the North line of Main Street to the West line of the north-south alley between 5th Avenue and 6th Street; Thence north along said West alley, line to the South line of Lot 6 of the Central Addition to the City of La Crosse; Thence west-northwest along said South line extended to the western line of 5th Avenue; Thence north-northeast along the westerly line of 5th Avenue to the North line of State Street; Thence west-northwest along the North line of State Street to the West line of 4th Street; Thence north-northeast along the West line of 4th Street to the Southern line of Lot 10, Block 26 of the Plat of the Town of La Crosse; Thence west-northwest along the Southern line of said Lot 10; Thence north-northeast along the westerly line of said Lot 10; Thence north-northeast along the westerly line of said Lot 10 to the Southern line of vacated Pine Street; Thence west-northwest along the Southern line of vacated Pine Street; and Pine Street to the Western line of 2nd Street; Thence south-southwest along the Northern line of 2nd Street to the Northern line of Lot 7, Block 10 of the Plat of the Town of La Crosse; Thence west-northwest along the Northern line of Lot 7, Block 10; Thence south-southwest parallel to and 75 feet westerly of the Western line of 2nd Street to the Southern line of Vine Street; Thence west-northwest along the Southern line of Vine Street to the Eastern line of Front Street; Thence south-southwest along the Eastern line of Front Street to the Southern line of State Street; Thence west-northwest along the Southern line of State Street to the Western line of Front Street; Thence south-southeasterly along the Western line of Front Street to the intersection of the South line of Riverside Park and the Western line of Front Street, said intersection point being 20 feet north-easterly of the South line of Lot 1, Block 1 of the Dunn, Doussman and Cameron Addition to the City of La Crosse; Thence west along a line parallel to and 20 feet north of the South line of said Lot 1, Block 1 of the Dunn, Doussman and Cameron Addition to the Eastern bank of the Mississippi River; Thence southerly along the Eastern bank of the Mississippi River to the North line of Cass Street and the Point of Beginning.
