THE CITY ASKS YOU TO REMOVE NUISANCE STATED BELOW BY **05/01/2014**.

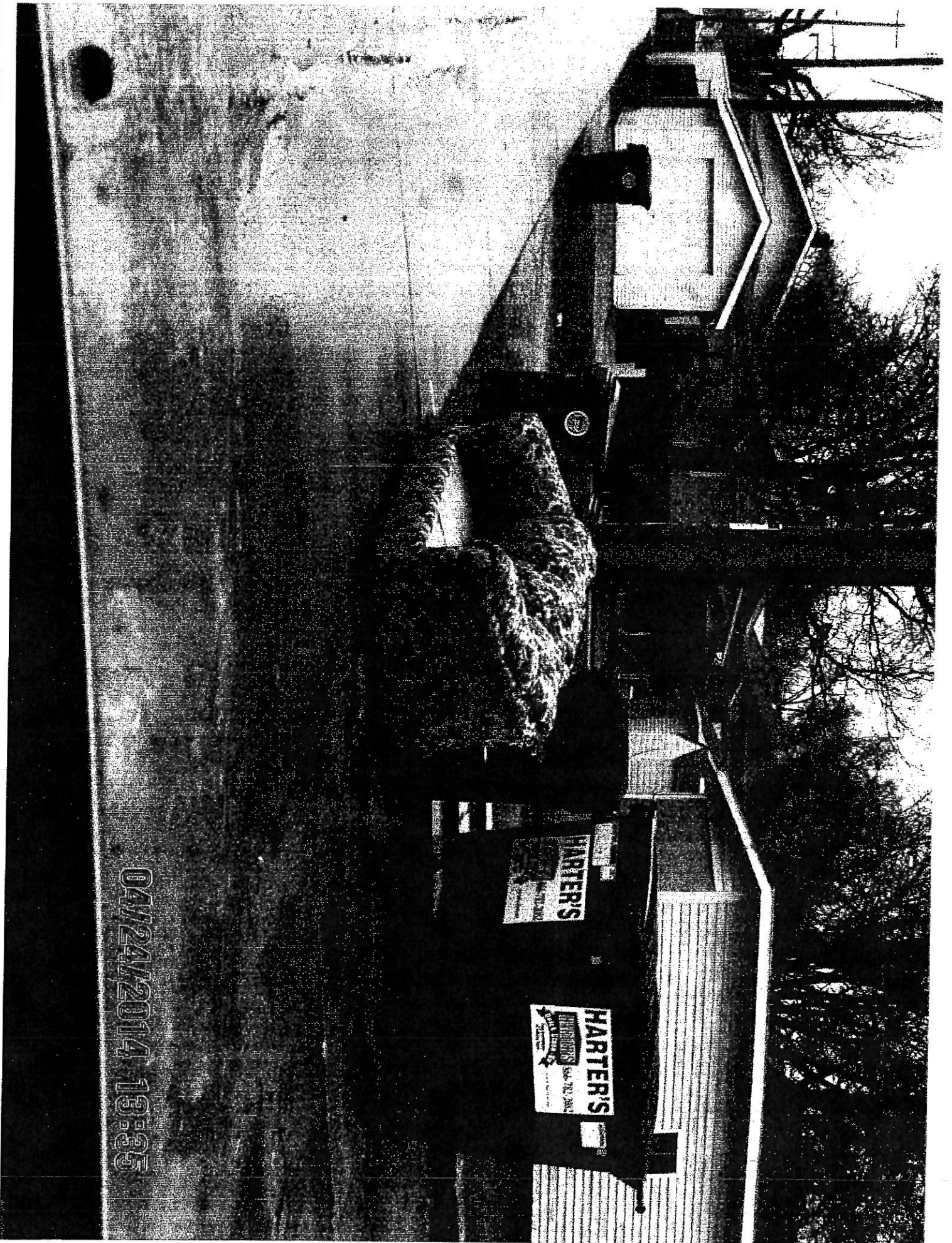
NUISANCE: Remove unlicensed vehicle from parking lot or have currently licensed and all tires inflated. Remove couch from outside storage.


