amend Subsection 115-110 of the  
Code of Ordinances of the City of La  
Crosse by transferring certain prop-  
erty from the Multiple District to the  
Traditional Neighborhood District -

single multi-family building at 415  
12th Street N., 1117,1119, 1125,  
1129, 1131, & 1135 Pine Street.  
THE COMMON COUNCIL of the  
City of La Crosse do ordain as  
follows:  
SECTION I: Subsection 115-110 of  
the Code of Ordinances of the City of  
La Crosse is hereby amended by  
transferring certain property from the  
Multiple District to the Traditional  
Neighborhood District - General &  
Specific on the Master Zoning Map,  
to-wit:  
Tax Parcel 17-20160-20; 415 12th  
Street N  
Tax Parcel 17-20200-60; 1117 Pine  
Street  
Tax Parcel 17-20200-70; 1119 Pine  
Street  
Tax Parcel 17-20200-80; 1125 Pine  
Street  
Tax Parcel 17-2000-80; 1129, 1131,  
& 1135 Pine Street  
SECTION II: Said rezoning is ap-  
proved with the condition that the  
design standard requiring rooflines  
longer than 40 feet to be broken up  
by an architectural element be met.  
SECTION III: Should any portion of  
this ordinance be declared uncon-  
stitutional or invalid by a court of  
competent jurisdiction, the remainder  
of this division shall not be affected.  
SECTION IV: This ordinance shall  
take effect and be in force from and  
after its passage and publication.

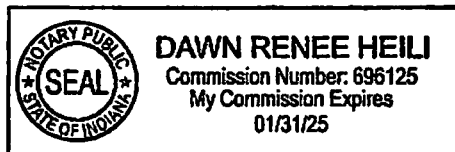
