## Flood Evacuation Plan and Agreement For Pettibone Resort

Pettibone Resort 333 Park Plaza Dr La Crosse, WI 54601

Whereas an annual agreement is required per City Ordinance 115-279 (4) & (5) and NR 116.12 (2) (b), this Flood Evacuation Plan and Agreement will also serve as a general emergency action Plan. It describes action to be taken before, during and after emergencies that should minimize personal and property damages and concurrently assists in recovery and is made by and among the City of La Crosse, Wisconsin, a Wisconsin municipal corporation with offices located at 400 La Crosse Street, La Crosse, Wisconsin, 54601 (city) and Pettibone Resort, La Crosse, Wisconsin, 54601 ("owner")

This document consists of 5 pages to include a signature page plus enclosures 1 and 2.

The EAP and evacuation schedule will not be altered without the expressed concurrence of the appropriate City of La Crosse Officials.

This EAP agreement is valid for a period of one (1) calendar year from the date approved by the designated City Officials.

### General Preparation and Information:

- \* The Resort requires all Recreational Vehicles (RV's) to be in working order, licensed and road ready at
- \* The Campground Manager maintains a current list of all occupied campground sites as well as phone numbers and permanent addresses for all seasonal campers.
- \* The elevation levels of the campground range from a river stage low of 6.33 to a high of 14.0 feet. Consequently, there is a significant variance in the flood stage levels in which campsites would have to be evacuated. Historically, the Mississippi River experiences flooding conditions in the spring months of
- \* The Campground is a seasonal operation. The campground is closed to camping from mid November to April. The campground has 300 total camping sites: 108 tent sites and 192 sites for recreational vehicles. This plan does not provide for the detailed site by site evacuation of tent sites. Prior to Memorial Day, May  $30^{\text{th}}$  of each year, the occupation of these sites is extremely limited and easily controlled. If flood stage levels are predicted, the limited occupation of tent sites could be evacuated in less that an hour notification and continued occupation suspended.
- $^{*}$  The campground does permit the unoccupied storage of RV's during the off season. These RV's are required to be immediately road ready for evacuation, including personal items. The maximum number of RV's located on the campsites in the spring period number approximately 100. The campground operator has the capability of evacuating this number of RV's in 8 hours or less although there is no precedence of an evacuation requirement of this magnitude.
- $^st$  Historical data shows that the maximum rate that the river has risen was approximately 6" in any eight hour period. The Mississippi is not subject to "flash flooding". With constant monitoring of river stage projections, the campground operator has excess capacity to insure that all campers are evacuated out of the flood plain in ample time to insure a safe and orderly process. Historical data shows that river stage projections are conservative with new technology making significant advances in the reliability of the projections. Still the guiding principle is to over estimate. However, the operator uses these projections to initiate evacuation of campsites which in itself insure an extra margin of safety. Signage:

- \* Signs stating that the campground is located in a floodway are positioned at the entrance of the campground and that flood evacuation procedures are available at the camp ground office.
- \* Both seasonal and temporary campers sign a contact or are notified upon registration that the campground is in a floodway.

#### Service Facilities:

Upon receiving notification of a flood stage reaching 12', water and electricity to the campground will be shut off as a conservation measure. All electrical outlets in the campground are elevated well above the 12' level. (There are no sanitary sewers, gas lines, propane storage tanks or wells located in the campground floodway.) The Resort contracts with Waste Management of La Crosse for regularly scheduled trash removal. They are notified when dumpsters need to be removed from the floodway.

### Notification of Projected Flood Conditions:

- \* When the river is projected to exceed 7' in the La Crosse area, the Campground Manager will conduct daily monitoring of current and projected river stages. The Resort is enrolled in the United States Weather Service Notification System.
- \*If the river stage is projected to exceed 8' within the next 72 hours, the campground manager will initiate the alert notification of all effected campers by phone or campground personnel making a personal visit to each site and warning each to make appropriate preparations for evacuation. Site evacuation includes not only the RV but unsecured personal items and appurtenances from the flood plain. As the river stage is projected to reach a river stage level shown on the list, campers and the operators will have 8 hours to complete the evacuation of those sites. This is considered ample time at each level to complete the required evacuation.
- \* Each seasonal camper has contractually agreed to evacuate or to arrange for the evacuation of their RV and their personal items from the floodplain. If we are unable to contact a camper, Resort management has the authority, the trained personnel and will remove the RV and associated items from the campground.

#### **Evacuation Vehicles:**

John Deere tractor and New Holland tractor.

Under normal conditions – 25 units per hour.

When river is rising rapidly – capable of 35 units per hour.

We have never had to pull more than 10 units per hour.

#### RV parking outside the floodway:

The principal area would be the resort parking area and approved portions of North and South Pettibone Drive. ( maps enclosed)


#### Campground Re-entry:

The resort staff is trained and experienced in cleanup procedures to include proper attire to insure a safe and appropriate cleanup of the campground. Campers will not be re-admitted until the campground is free of debris, repaired as necessary and safe for children and families. Re-opening of the campground will be coordinated with the Director of Parks and Recreation.
