Moved in and received a letter stating I needed to move out, it was a month to month lease unfortunately am aware she can legally do this, but had absolutely no reasoning behind it, she told me if I moved out early, she would give me part of my rent back, I moved out exactly half way thru the month and only received \$75 back, also she took over \$600 of my security deposit when I left it cleaner than when I moved in, it was spotless and I spent hours cleaning to ensure I got my full deposit back and got nothing, leaving me and my son with nothing to move out, she did this to my neighbor I had there at the time and many other people as well she also knew I needed a parking pass, I told her when imagining the lease and failed to give me one in my packet with keys prior to moving in, witch then led my car to get towed, costing me over \$200 to get out, I wasted so so much money moving into this place just to get kicked out probably for a friend of hers who needed a place to live, not sure 100% but she deffinetly left me high and dry for no reason. She set me back so far and I don't even know why, I was at the time pregnant with a 4 year old, I went to work came home and went to bed early, I didn't cause any disruptions and was always respectful of my neighbors. Also, when I finally got my parking pass, she sent her boyfriend to put it on who was clueless about any and all questions I had.
