NOTICE IS HEREBY GIVEN that the Common Council of the City of La Crosse, by its Judiciary & Administration Committee, will hold a public hearing on a proposed ordinance change in the zoning code as follows:

AN ORDINANCE to amend Sub-section 115-110 of the Code of Ordinances of the City of La Crosse transferring certain property from the Traditional Neighborhood District - General to the Traditional Neighborhood District - Specific allowing addition to building at 1514-1516 Market Street.

Property is presently used for: An arts and crafts workshop and gift shop.

Property is proposed to be used for: Same use, additional workspace for art business.

Rezoning is necessary because: By rezoning, the building will be more appropriately designated for its intended purpose.
