THE CITY ASKS YOU TO REMOVE NUISANCE STATED BELOW BY **12/19/2014**.

NUISANCE: Clean up garbage in front and side yards. Place in proper receptacles for pickup. Remove concrete blocks in front yard. Remove old wooden garbage stand in side yard. Remove carpet in driveway all from outside storage.
