

Vacation of all Right of Way known as Fairview Drive in said SW ¼ of the NW ¼ and the SE ¼ of the NW ¼ of Section 21;

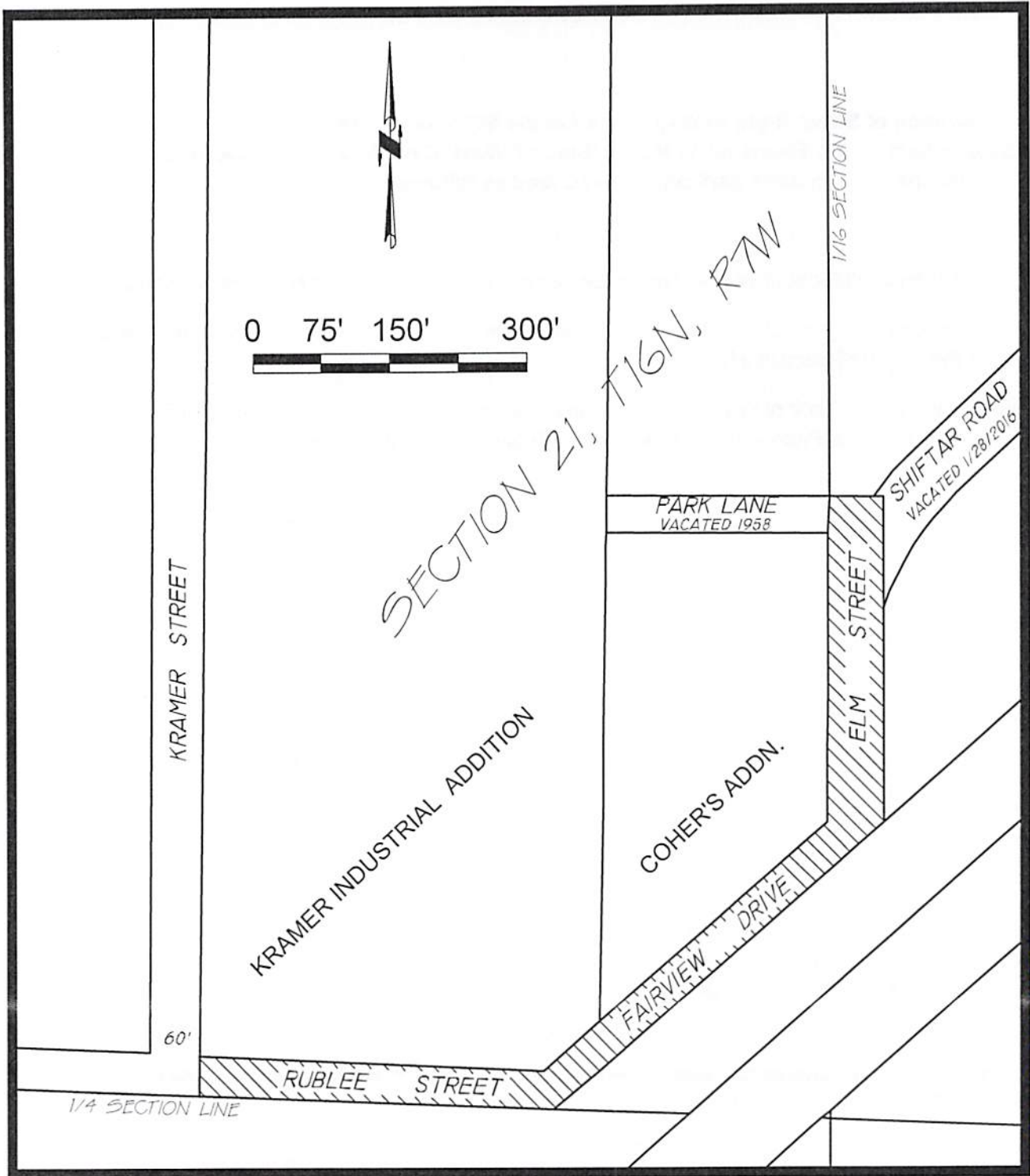
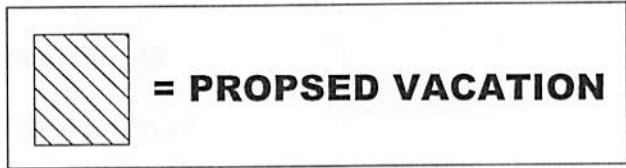
