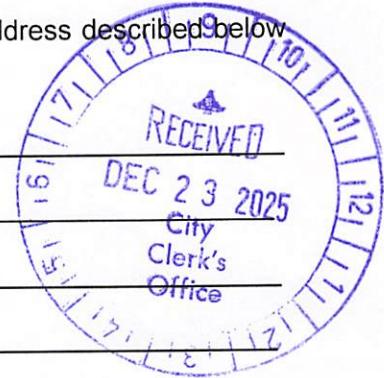

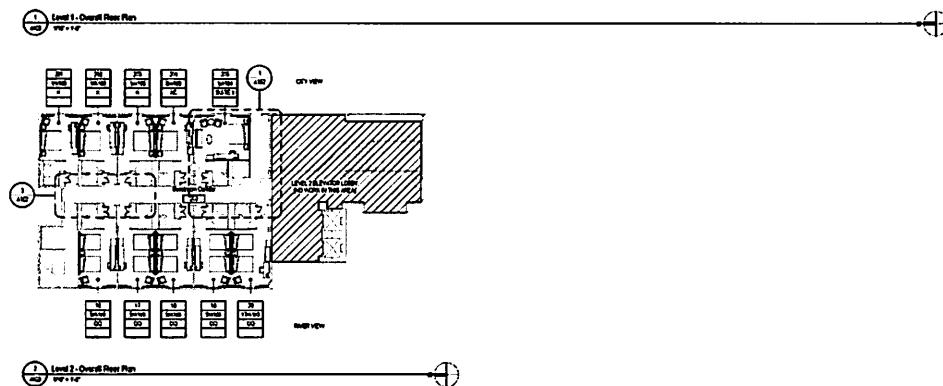

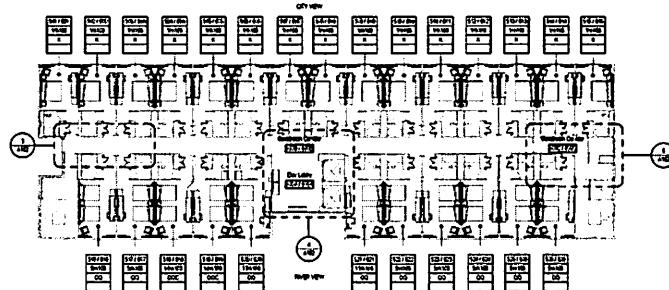

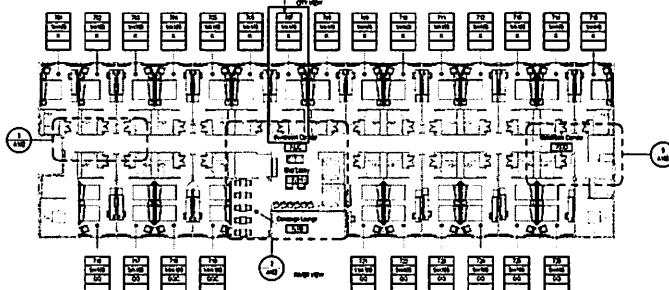


3 Level 3-4 - Over 8 River Flows

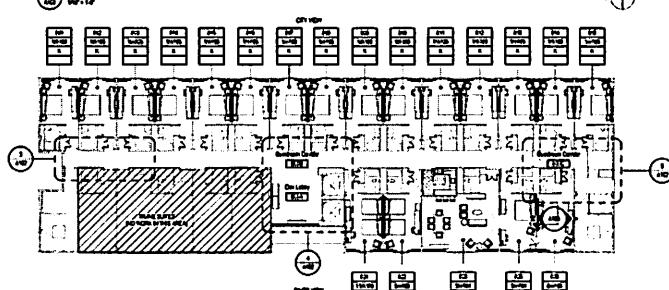
