## NOTICE OF INTENT NOT TO RENEW LICENSE

**Miguel Guerrero (Officer) and Luis Guerrero Chavolla (Agent) for Chabolla Corp. dba Tequila Mexican Restaurant, 515 West Ave. N., La Crosse, Wisconsin.**

### *Basis for Intent to Not Renew*

This is to notify you that the City of La Crosse intends to not renew the Combination "Class B" Beer and Liquor License issued to Chabolla Corp. for license year July 1, 2026 through June 30, 2027.

Pursuant to Wis. Stat. § 125.12(3), a municipality may refuse to renew a license for certain violations identified in § 125.12(2)(ag), including violations of municipal code or municipal regulations and maintaining a disorderly house.

The City of La Crosse alleges that the use of the establishment is interfering with public health and safety and is grounds for non-renewal of its Combination "Class B" Beer and Liquor License under Wis. Stat. § 125.12(2)(ag) for violations of municipal code or municipal regulations and for maintaining a disorderly house. This is supported by the following:

- (1) Violation of Resolution 44736 adopted August 13, 1987. This resolution established a general policy in connection with alcohol beverage licenses that three (3) violations of La Crosse Municipal Code and/or State laws per licensed establishment within a license year (July 1 through June 30 of the following year) shall be cause for a hearing before the Judiciary & Administration Committee as to whether the license should be suspended, revoked or non-renewed.

Chabolla Corp. dba Tequila Mexican Restaurant, 515 West Ave. N., committed and was convicted of three (3) violations in the current license year, July 1, 2025 through June 30, 2026, for sale of alcohol to underage individuals as follows:

- September 4, 2025, municipal ordinance citation: Ord. 4-7 Allow Underage in Bar. Per Municipal Court records, this citation resulted in a conviction on October 15, 2025. Matthew J. Memory (bouncer), Tequila Mexican Restaurant, 515 West Ave. N.
- February 25, 2026, municipal ordinance citation: Ord. 4-6 Sale/Furnish Liquor to Underage. Per Municipal Court records, the citation resulted in a conviction on April 1, 2026. Yolanda M. Hernandez Arquez (beverage server), Tequila Mexican Restaurant, 515 West Ave N.
- September 6, 2026, municipal ordinance citation: Ord. 4-7 Allow Underage in Bar. Per La Crosse County Circuit Court records, the citation resulted in a conviction on April 14, 2026. Luis Guerrero Chavolla (agent), Tequila Mexican Restaurant, 515 West Ave. N.

- (2) Violation of Chronic Nuisance Premises Abatement Plan Agreement. Representatives of the La Crosse Police Department and Chabolla Corp. (including Miguel Guerrero, owner, and Luis Guerrero Chavolla, agent) met on September 30, 2025 and agreed to a Chronic Nuisance Abatement Plan. Among other things, this plan requires the submission of monthly written reports to the Police Department detailing nuisance abatement. Chabolla Corp. has only submitted two (2) reports. Accordingly, Chabolla Corp. is in violation of the Abatement Plan for failing to submit the required monthly reports.

As part of the abatement process, City police have provided multiple alcohol compliance training sessions and opportunities to Chabolla Corp. and its employees, including beverage server trainings on July 17, 2024 and March 11, 2025.

- (3) Violation of Fire Code. During an inspection on December 4, 2025, the La Crosse Fire Department documented significant electrical issues at the establishment. This was communicated to Luis Guerrero Chavolla (agent), who was on site during the inspection. A follow-up inspection occurred on May 5, 2026; none of the previous electrical issues were fixed. The code issues were again communicated to

Luis Guerrero Chavolla, who was on site during the re-inspection. The electrical issues have not been corrected.

(4) Previous Violation of Resolution 44736. In 2024, the City issued Chabolla Corp a Notice of Intent to Not Renew License based on a violation of Resolution 44736 during the license year July 1, 2023 through June 30, 2024. Chabolla Corp. received the following three violations:

- August 31, 2023, municipal ordinance citation: Ord. 4-6 Sale/Furnish Liquor to Underage. Per Municipal Court records, this citation resulted in a conviction on September 12, 2023. Yolanda Hernandez (beverage server), Tequila Mexican Restaurant, 515 West Ave. N.
- February 1, 2024, municipal ordinance citation: Ord. 4-6 Sale/Furnish Liquor to Underage. Per Municipal Court records, the citation resulted in a conviction on February 7, 2024. Yolanda Hernandez (beverage server), Tequila Mexican Restaurant, 515 West Ave. N.
- April 5, 2024, municipal ordinance citation: Ord. 4-6 Sale/Furnish Liquor to underage. Per Municipal Court records, the citation resulted in a conviction on May 8, 2024. Franklin Flores Cruz (beverage server), Tequila Mexican Restaurant, 515 West Ave. N.

The City of La Crosse and Chabolla Corp entered into an agreement on June 4, 2024, and a non-renewal hearing did not occur. As part of this agreement, Chabolla Corp agreed to a ten (10) day license suspension and acknowledged that it was in violation of Municipal Code Sections 4-6 on three separate occasions in the license year July 1, 2023 to June 30, 2024.

(5) Significant Underage Activity. In addition to the above described violations, multiple incidents (bar checks) involving underage presence have occurred at the establishment over the past six (6) years. These violations include La Crosse Municipal Code Sections 4-7 (Allow Underage in Bar), 4-9 (Underage Possession/Consumption), 4-10 (Underage in Bar), and/or 4-11 (Underage Possession of False ID). The following are examples of these incidents and citations issued:

- September 19, 2025, La Crosse Police Department Case No. 10-25-42200: Five (5) underage consumption/underage related citations were written by officers and one Allowing Underage in Bar citation was issued.
- September 6, 2025, La Crosse Police Department Case No. 10-25-39979: Seventeen (17) underage consumption/underage related citations were written by officers.
- March 1, 2025, La Crosse Police Department Case No. 10-25-08482: Eighteen (18) underage consumption/underage related citations were issued by officers and two Allowing Underage in Bar citations were written by officers.
- September 19, 2024, La Crosse Police Department Case No. 10-24-42839: Four (4) underage consumption/underage related citations were written by officers.
- April 5, 2024, La Crosse Police Department Case No. 10-24-14531: Four (4) underage consumption citations were written by officers.
- August 31, 2023, La Crosse Police Department Case No. 10-23-41284: Two (2) underage consumption citations were written by officers.
- September 10, 2022, La Crosse Police Department Case No. 10-22-38673: Six (6) six underage consumption/underage related citations were written by officers.
- April 21, 2022, La Crosse Police Department Case No. 10-22-15650: Four (4) underage consumption/underage related citations were written by officers.

- December 10, 2021, La Crosse Police Department Case No. 10-21-52131: Five (5) underage consumption/underage related citations were written by officers.
- November 18, 2021, La Crosse Police Department Case No. 10-21-49256: Seven (7) underage consumption/underage related citations were written by officers.



**STIPULATION REGARDING ALCOHOL NONRENEWAL LICENSE(S)  
PROCEEDINGS WITH CHABOLLA CORP., D/B/A TEQUILA MEXICAN  
RESTAURANT**

*Background*

In May 2024, the City of La Crosse sought the nonrenewal of the Chabolla Corp.'s, d/b/a Tequila Mexican Restaurant, alcohol license(s) for failure to comply with La Crosse Municipal Code Section 4-6 sale of alcohol to underage. The code adopts the provisions of Wis. Stat. § 125.07(1) which governs alcohol beverages and restrictions relating to underage persons. The "Notice of Intent to Not Renew License" document on file as Legislative Item 24-0704 more specifically details the violations and is incorporated by reference.

Pursuant to Wis. Stat. § 125.12(3), a municipality may refuse to renew a license for certain enumerated violations listed in Wis. Stat. 125.12(2)(ag), which includes certain violations of municipal code or municipal regulation.

*Agreement*

The City of La Crosse ("The City") and Chabolla Corp., d/b/a Tequila Mexican Restaurant ("Tequila's") agree to the following:

1. Tequila's acknowledges that it was in violation of Code Sections 4-6 on three separate occasions in the license year July 1, 2023 to June 30, 2024. Tequila's has taken efforts in response to the pending nonrenewal of its alcohol license(s) to comply with alcohol regulations.
2. The parties agree that Tequila's alcohol license(s) may be renewed for license year July 1, 2024, through June 30, 2025, with the following conditions:
  - a. The license(s) will be suspended for a period of ten (10) days beginning July 1, 2024.
  - b. Alcohol education training with the City of La Crosse Police Department must be completed within sixty (60) days, unless the Police Department agrees to extend the time.
  - c. That an abatement meeting with signed abatement plan with the City of La Crosse Police Department must be completed within sixty (60) days, unless the Police Department agrees to extend the time.
  - d. All servers at Tequila's must obtain City beverage operator license (commonly referred to as "bartender license") within sixty (60) days. Any newly hired servers should be licensed within sixty (60) days of employment.
  - e. Signage shall be displayed at the entry and on tables that Tequila's checks IDs. The City Clerk may be consulted and can provide language for such signage. Implementation is to be completed as soon as possible but no later than July 11, 2024.

f. If Tequila's receives three (3) alcohol related violations during the 2024 – 2025 license year, its alcohol license(s) will be automatically revoked for the duration of the license year, upon notice and without hearing.

g. Tequila's will comply with all applicable state and local laws.

3. The City will cease its May and June 2024 nonrenewal efforts as it relates to Tequila's alcohol license(s).

Hannah Boldebeck, being first duly sworn, on oath, states as follows:

1. I am a first-year student at the University of Wisconsin-La Crosse, and I make this affidavit based on my own personal knowledge.
2. I am currently 18 years old, and my date of birth is December 31, 2006. I live in the City of La Crosse, Wisconsin.
3. I received citations for being underage in a bar and possession/consumption of alcohol 17-20 at Tequila's Bar & Grill ("Tequila's"), reference Case No. 10-25-39979, on September 6, 2025. Several of my friends, all under the age of 21 and most of whom are first-year students, were also present at Tequila's that night and consumed alcohol on premises.
4. Upon information and belief, Tequila's is well-known among college students in La Crosse as being easy for underage adults to be admitted and purchase and consume alcohol on the Tequila's premises. I became aware of this reputation from classmates of a similar age. It is known that you need to have some form of identification showing that you are above 21 years old, but the employees checking IDs have a reputation for not really looking at the IDs or check to see if the ID matches the person showing the ID.
5. When I received the citation on September 6, 2025, that was the second time I had been to Tequila's. The first time I was at Tequila's was the day before, September 5, 2025.
6. On September 6, 2025, I went to Tequila's with people that I knew to be underage.
7. When I entered Tequila's on September 6, 2025, there was not any bouncer or ID checker there. I went to the left when I entered Tequila's, which is where the Bar Only area is located,

and there was an employee near the bar area. The employee asked to see IDs. I handed him a fake ID that looked similar to a Wisconsin driver's license. The process of having my ID checked by the employees was extremely fast. Based on my recollection, my ID was not scanned. I was never asked for a second form of ID or asked my date of birth.

8. On both September 5 and September 6, 2025, I never observed bartenders at Tequila's requesting ID from patrons when ordering alcoholic beverages, nor have I ever seen or heard of someone presenting ID to a bartender. Both my friends and I have ordered alcoholic beverages from Tequila's.

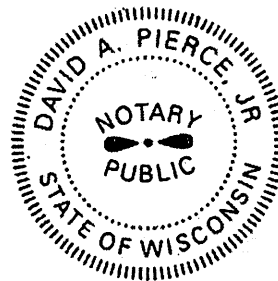

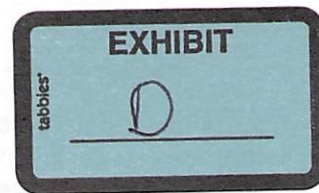

Dear Miguel Guerrero & Luis Guerrero:

This letter is regarding property that you own and/or operate at the above address in the City of La Crosse. Per Chapter 30.28 of La Crosse City Ordinance, this property meets the definition of a chronic nuisance premise.

Since September 1, 2024, police have responded to 515 West Avenue North (Tequila Mexican Restaurant) for 34 calls, of which four are deemed "nuisance" calls that produced 45 citations to include Allow Underage in a Bar (ordinance 4-7), Underage in a Bar (ordinance 4-10), and Underage Possession/Consumption of Alcohol (ordinance 4-9).

As the owner of the property, the law places a burden on you to ensure that the public nuisance is stopped. This notice is being provided to give you an opportunity to do so. If you fail to act under Chapter 30 Article II, as the property owner, you may be subject to the following:

1. Citation(s) for Maintaining a Public Nuisance, with fines not less than \$100 nor more than \$1,000, together with the cost of prosecution for the first offense and not less than \$200 nor more than \$5,000, together with the cost of prosecution for subsequent violations.
2. Bill(s) for police, fire, and inspection services at the property due to your failure to eliminate the nuisance activity. If not paid, the bill amounts may be assessed as a special charge against the premises. An appeal for this bill may be submitted to the City Clerk.
3. Additional legal action against the owner/property by the City through Circuit Court.

You are hereby ordered to attend a meeting to discuss the abatement of the above-mentioned property on September 30, 2025, at 10 a.m. at La Crosse City Hall 400 La Crosse St. La Crosse, WI 54601. Failure to attend this abatement meeting could result in you receiving a citation pursuant to the La Crosse Municipal Code. Enclosed with this letter are the listings of occurrences from the police department, a copy of the Chronic Nuisance Ordinance, and an Abatement Plan that will be reviewed with you during the meeting on September 30<sup>th</sup>.


Hopefully the above penalties will not be necessary. We are willing to assist you in resolving this situation. Please contact Lt. Steve Pataska (608-789-7205) within the next five days to confirm your attendance at the meeting or to set a new meeting date if you are unable to

attend the scheduled meeting. Please feel free to contact me prior to the meeting with any questions or concerns. Our experience has shown that prompt attention to these matters can help you avoid legal consequences.





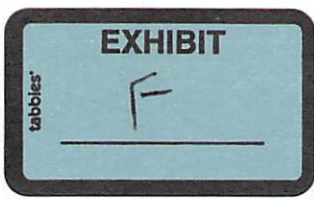

**SUMMARY:**

On March 1, 2025 at 9:47 p.m., a bar check was completed at Tequila’s Mexican Restaurant, at 515 West Avenue North in the City of La Crosse. In total, 18 underage consumption citations were written by officers and two allowing underage in a bar citations were written by officers during this bar check. No further follow up is needed with this initial report. See all other officers’ supplemental reports for further details.

**NARRATIVE:**

**INITIAL OBSERVATIONS:**

On March 1, 2025 at 9:40 p.m., I initiated a traffic stop on a vehicle at West Avenue and La Crosse Street for no lights. The vehicle proceeded past the intersection and all the way down to Tequila’s Restaurant, at 515 West Avenue North, which is to the south of West Avenue in La Crosse. It then pulled into the Tequila’s front parking lot and parked. I had my emergency lights activated and went on with the traffic stop portion, where I issued a written warning. See Case #25-08480 for further details.

As I was attempting to complete this traffic stop, I noticed several people from the inside upper bar area at Tequila’s, all of which appeared to be younger in age, looking outside at my marked patrol vehicle with its emergency red and blues on. As I was attempting to speak with the driver of the vehicle during my traffic stop, I heard a large commotion behind me. I turned around and noticed several, approximately 20 to 30, younger college-aged individuals leave the back door of the upper bar area. They jumped onto the outdoor patio that had been blocked off. They began running into and tripping on the stacked chairs, due to it being wintertime outside. This was also not a normal door that would be used during the wintertime. They then all began jumping the patio fence, screaming that the police were here. This was not a normal response, nor was I at the

bar for any reason other than being in their parking lot for the traffic stop. I informed other officers of the commotion and to come to my location for a possible bar check, due to this unnatural reaction from police presence.

After I was completed with the traffic stop and released the driver from the initial traffic stop, Officer Morris had already started a bar check reference this incident. Officer Beardmore waited near the patio area on the west side of the rear door to the upper bar area, while Officer Morris and I went inside. Officer Morris and I went to the upper bar area and noticed several individuals who appeared to be looking away from us, along with several individuals that ran to the bathroom areas near the rear patio doors. Several others also tried to go out of the exit doors, however, Officer Beardmore was there, who they noticed in full uniform, and came back into the bar and attempted to blend in at the bar.

When observing the crowd inside the upper bar area, they did have a bouncer stationed out in front of it. I recognized no one appeared to be over the age of 21 and looked to be significantly younger. Due to this, and there being so many, I called for additional officers and also La Crosse Police Command staff. Additional officers did arrive on scene, along with Sergeant Mandujano. I briefed all of them on my observations, along with Sergeant Mandujano, and advised we were going to ID everyone in the upper bar area due to the ages and reactions.

#### **CONTACT WITH DEVON BOSTWICK:**

As officers began making contact with people, I made contact with Devon Bostwick. Devon advised he did not have identification on him, nor any form of ID. Devon informed me he was underage and had been drinking alcohol. I could also smell the odor of alcohol emitting from his breath while he was speaking. His speech was slurred and his eyes were bloodshot and glossy.

I walked Devon outside to my marked patrol vehicle, parked in the front lot still. There, I verified his information he gave me verbally. I looked up his Wisconsin driver's license photo, which did match Devon Bostwick, who I had with me. When running his information through La Crosse County Dispatch Center, they advised he had two prior underage consumption citations already. Devon also informed me he was familiar with this process and understood he would be receiving a citation.

When asking Devon if he would provide a PBT sample, he refused and did not want to provide a PBT sample. Devon was issued a citation for possession/consumption of alcohol, municipal ordinance 4-9. He was explained the citation in full and released.

#### **CONTACT WITH BRENDEN VAUGHAN:**

Officer Abraham walked out to my patrol vehicle, where I was with Devon Bostwick and Brenden Vaughan, who was also inside the bar. Brenden was identified by Officer Abraham by his Wisconsin driver's license.

Due to the large amount of people inside and Officer Abraham trying to get back inside to assist officers, he was turned over to me for being in the bar underage and also admitting to consuming alcohol. Brenden submitted to a PBT and registered a .009 on the PBT.

When running Brenden's information through La Crosse County Dispatch Center, they advised this was his first offense UAL. Brenden was issued a citation for possession/consumption of alcohol underage, municipal ordinance 4-9. He was furnished with the citation and advised he had no further questions. He was released.

### **CONTACT WITH TROY DAVIS:**

I also made contact with Troy Davis, who was also inside the bar. Troy immediately informed me he was underage and also consumed alcohol. Troy identified himself by his Minnesota driver's license.

Troy did walk outside with me, where he did submit to a PBT, which registered a .084 on the PBT. Troy was very cooperative throughout this process.

When running his information through La Crosse County Dispatch Center, they advised this was Troy's first offense UAL. Troy was issued and furnished with a copy of his citation for municipal ordinance 4-9. Troy advised he had no further questions and was released along with his friends to walk back to the dorms at UW-La Crosse.

### **CONTACT WITH MIGUEL GUERRERO:**

Sergeant Mandujano made contact with Miguel Guerrero, one of the Managers on duty and advised he was the owner of the Tequila's. His information was also found in local RMS, also stating he was the owner of Tequila's.

Miguel was informed of the situation tonight and the issues that arose. He was informed almost everyone found in the upper bar area was underage. Sergeant Mandujano continued contact with him via phone, as he was not there on scene. See Sergeant Mandujano's report for further details.

Miguel was informed he was going to be receiving a citation for allowing underage persons in the bar. He advised he understood and it could be left at the bar for him. On 03/05/2025 at 3PM, I completed a citation for the business of Tequilas for allowing underage persons in the bar. It was left with La Crosse Police front end staff to be mailed.

I also left Miguel and staff at Tequila's my business card in case there were any further questions.

### **CONTACT WITH NOAH COLEMAN:**

I made contact with the front bar bouncer, Noah Coleman. Noah was identified by a Wisconsin driver's license. Noah was very cooperative and advised he ID'd everyone that came into the bar area.

Several individuals, including the individual I spoke with, Troy, advised he had gotten up to the bar by jumping over the side patio and coming in through the side door that was opened for him by someone inside. Where Noah was positioned, he could only see anyone coming in from the front door or coming from the restaurant area. There were two doors behind him, one that went out the west side of the bar area and then also one that went out to the south side. From where Noah was, he could not see these exits unless he looked into the bar. Noah again clarified he identified everyone that came into the bar. I informed him how people were telling officers they were getting inside. I also informed him several individuals did not even have identification on them.

After speaking with La Crosse Police Command staff, it was determined a citation for Noah, being the single bouncer, would be appropriate in this incident for allowing underage persons in a bar. Noah was issued a citation for municipal ordinance 4-7. He was explained the citation and released without any further questions.

### **DISPOSITION:**

Several other individuals ran out the back door when officers were just getting inside of the bar. I saw another approximately 20 to 30 people that ran out the back of the bar as well when I was making the traffic stop. I informed all the subjects I issued citations to that this unnatural reaction is what prompted this bar check. All advised they understood and also saw the numerous people run outside when I made the traffic stop outside of the bar.

In total, 18 underage consumption citations were written and also two allowing underage persons in a bar citations were written as well. No further immediate follow up is needed with this initial report.

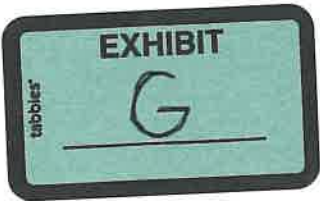

## NOTICE OF INTENT NOT TO RENEW LICENSE

**Inderyas Chiraghdin (Member and Agent), Mema Enterprises LLC dba Citgo on State, 1914 State Road, La Crosse, Wisconsin.**

### *Basis for Intent to Not Renew*

This is to notify you that the City of La Crosse intends to not renew the "Class A" Liquor; Class "A" Beer; and Cigarette, Tobacco and Electronic Vaping Device licenses issued to Mema Enterprises LLC for license year July 1, 2026 through June 30, 2027.

Pursuant to Wis. Stat. § 125.12(3), a municipality may refuse to renew an alcohol license for certain violations identified in § 125.12(2)(ag), including violations of municipal code or municipal regulations, such as when a person does not possess the qualifications required to hold a license, and for maintaining a disorderly house.

Pursuant to Wis. Stat. § 134.65(8) a municipality may refuse to renew a cigarette, tobacco and electronic vaping device license for certain violations identified in § 134.65(7), including violations of municipal code or municipal regulations, such as when a person does not possess the qualifications required to hold a license, when a person has knowingly permitted criminal behavior to occur on the licensed premises, and for maintaining a disorderly house.

The City of La Crosse alleges that the use of the establishment is interfering with public health and safety and is grounds for non-renewal of its "Class A" Liquor license; Class "A" Beer license; and Cigarette, Tobacco and Electronic Vaping Device license under Wis. Stat. §§ 125.12(2)(ag) and 134.65(7) for violations of municipal code or municipal regulations and for maintaining a disorderly house. This is supported by the following:

- (1) Lack of Qualifications. Mema Enterprises LLC Member and its Agent, Inderyas Chiraghdin, do not possess the qualifications to hold a license due to a pending criminal charge that substantially relates to the licensed activity. The matter is currently pending in La Crosse County Circuit Court and involves a Class H felony charge related to the possession of prescription medication.
- (2) Enforcement Actions. There have been multiple La Crosse Police Department incidents of disorderly, riotous, indecent, or improper use of the premises, including:
  - September 4, 2025, La Crosse Police Department Case No. 10-25-39593: The La Crosse Police Department conducted a compliance check which resulted in an officer issuing a Section 4-6 citation to employee Muhammad Tariq for selling alcohol to an underage individual. Per Municipal Court records, this citation resulted in a conviction on October 10, 2025.

This incident also implicates Municipal Code Section 10-171(k): "*Violations by agent or employee of licensee*. A violation of this article by a duly authorized agent or employee of the licensee shall constitute a violation of the licensee. Violations of the provisions of this article or the provisions of Wis. Stat. § 134.65 may be grounds for immediate revocation by the Common Council."

- November 17, 2025, La Crosse Police Department Case No. 10-25-51921: The La Crosse Police Department conducted a compliance check with the Department of Revenue and discovered various concerning items related to the consumption of illegal substances. A box containing 175 Malegra (sildenafil) 200mg tablets was discovered underneath the counter. These tablets are commonly known as Viagra and only available by prescription in the United States. The cashier informed officers that they sell them for \$7 each to anyone who asks. Officers told staff it was illegal to sell the pills and seized them. In addition, officers discovered that the establishment's invoices for their alcohol purchases were not organized and dated as required by the State.
- February 4, 2026, La Crosse Police Department Case No. 10-26-04730: The La Crosse Police Department conducted a compliance check with the Department of Revenue and again discovered sildenafil (generic Viagra) 200mg tablets behind the counter. This was the second time the La Crosse Police Department located these illegal pills at the establishment. Officers also located portions of the original packaging which visibly stated, "available by prescription only." When officers spoke with Inderyas Chiraghdin and asked about the pills, he said, "they are for sex." Inderyas Chiraghdin was arrested and released on a signature bond for delivery of prescription medication.

The La Crosse Police Department also discovered that the pills are not available commercially in the United States. In addition, the 200mg dosage of the pills exceeds the dosage available for prescription in the United States.

In addition, multiple violations related to tobacco and vaping products were identified. The Department of Revenue confiscated several illegal vaping products. Further, the establishment also did not have signage for their hemp-derived cannabinoid inventory. Mema Enterprises LLC was cited for Failure to Post Signage – Hemp-Derived Cannabinoids in violation of Municipal Code Section 32-165. Per Municipal Court records, this citation resulted in a conviction on February 26, 2026.

- (3) Application. Regarding applications for intoxicating liquor and fermented malt beverage licenses, Municipal Code Sections 4-72(b)(6) and 4-142(b)(6) state, "Any false statement contained in such application shall automatically nullify any license issued pursuant thereto." The 2026 renewal applications submitted by Mema Enterprises LLC do not disclose the Sec. 32-165 conviction against the establishment.

The 2026 renewal applications acknowledge a pending charge which is accompanied by the following statement: "A vendor sold me an erectile product which, unknown to me, might or might not contain a prescription medication for erectile dysfunction. TBD." This directly contradicts what Inderyas Chiraghdin told officers during the February 4, 2026 compliance check and mischaracterizes the pending felony.



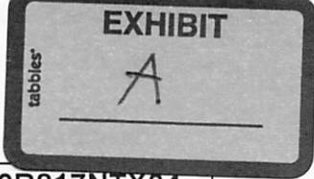

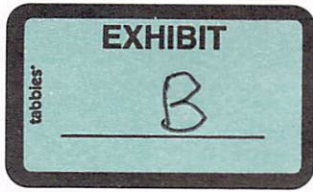

**SUMMARY:**

On 11/11/25 I conducted a bar check at Citgo Gas station located at 1914 State Rd. with the Department of Revenue Alcohol Division. During my check I located several concerning items related to the consumption of illegal substances to experience a high. Several generic Viagra pills were located which are only available by prescription. These pills were seized and further investigation is being conducted to determine if criminal charges will be filed.

**NARRATIVE:**

**BAR CHECK:**

On 11/17/25 Officer Abraham, The Department of Revenue Alcohol Division, and I conducted a bar check at the Citgo gas station. During this check we observed their invoices for their alcohol purchases were not organized and dated as required by the state. They were educated on how to fix this. We also discovered several "legal" items that are commonly used for ingesting illegal substances.

**CRIME STOPPERS TIP/INFORMATION:**

The La Crosse Police Department has received Crime stoppers tips expressing concern that Citgo does not check individual ID's when alcohol is purchased. The tipster explained that underage individuals know this and will actively travel to this location to obtain alcohol. They failed a compliance check earlier this year and were cited for failure ref #25-39593.

There was also information provided that in the past they have sold "everything but kits" which in street terms means individuals could purchase kits containing glass pipes, steel wool, matches, and small tin containers to assist in their consumption of illegal drugs. These items individually are not concerning but when sold cause for concern as they can be used together to heat up, filter, and consume illegal substances.

### **ITEMS LOCATED:**

During our inspection we located a variety of legal items behind the counter and in the back storage area. These items are legal to possess and by themselves are not a concern but when sold in combination with other items and from my training and experience conducting drug investigation, Drug Recognition Expert evaluations and interacting with the public over my career there is a concern with what these items are being used for. The following was discovered:

#### **Glass pipes:**

There were hundreds of clean glass pipes which are commonly used by individuals to consume illegal substances ranging from THC, cocaine, methamphetamines and even heroin. The substances are traditionally heated up and ingested by inhaling the substance.



#### **Gem baggies:**

We located numerous clean clear gem sized baggies which are commonly used to store and transport illegal substances by individual users. These were decorated with a variety of markings ranging from THC leaves to other colorful designs.



**Nitrous oxide:**

We located hundreds, if not thousands of nitrous oxide cans ranging in sizes from large (2KG) to single serving N2O cream chargers (9oz). These are commonly sold and used in the food industry by chefs and bakers for whip cream dispensers. The ones that were located at Citgo were flavored and Citgo is not known to take part in any food creation or distribution besides the prepacked food they order and sell as part of their business.

These “whippets” are commonly utilized by individuals to get a short high that causes euphoria and a feeling of detachment. Symptoms of use can be a loss of consciousness, dizziness, slurred speech, blurred vision, and headaches. These can be very dangerous to users and cause brain damage, nerve damage, and dependency. I spoke with the cashier at the time of the check and when asked why they had them he could not provide an answer and confirmed they did sell them.

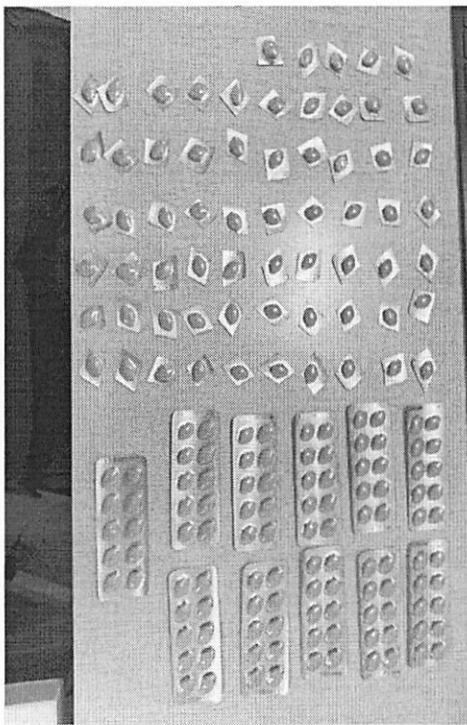
A few weeks prior to our compliance check our patrol staff responded to a call for service involving child neglect and it was discovered the dad of a small child was utilizing the exact same brand (Exotic Whip) and size nitrous oxide can that was sold at Citgo. He used them to get “high” and passed out while he was watching his child. This is why police were called to his residence. See case #25-49903 for further information.





### Malegra Tablets:

Underneath the counter we located a small box which contained 175 Malegra (Sildenafil) 200mg tablets. They are commonly known as Viagra and used to treat erectile dysfunction. These are only available by prescription in the United States. I asked the cashier at the time what these were for and he stated they sell them for \$7 each to anyone who asks. He could not provide a prescription, and these pills were seized.

### ATTEMPTED CONTACT WITH INDERYAS CHIRAGHDIN:

I obtained information from city Clerk to determine who the owner of the gas station was. I called Inderyas Chiraghdin to speak with him about the concerning items that were located at his gas station including the available only by prescription tablets that were located and allegedly being sold over the counter, but he did not answer. I called her and left a voice mail requesting she call me back to discuss the items that were located at the gas station during our check. I have not received a phone call back. I will be stopping out at her address for further follow-up.

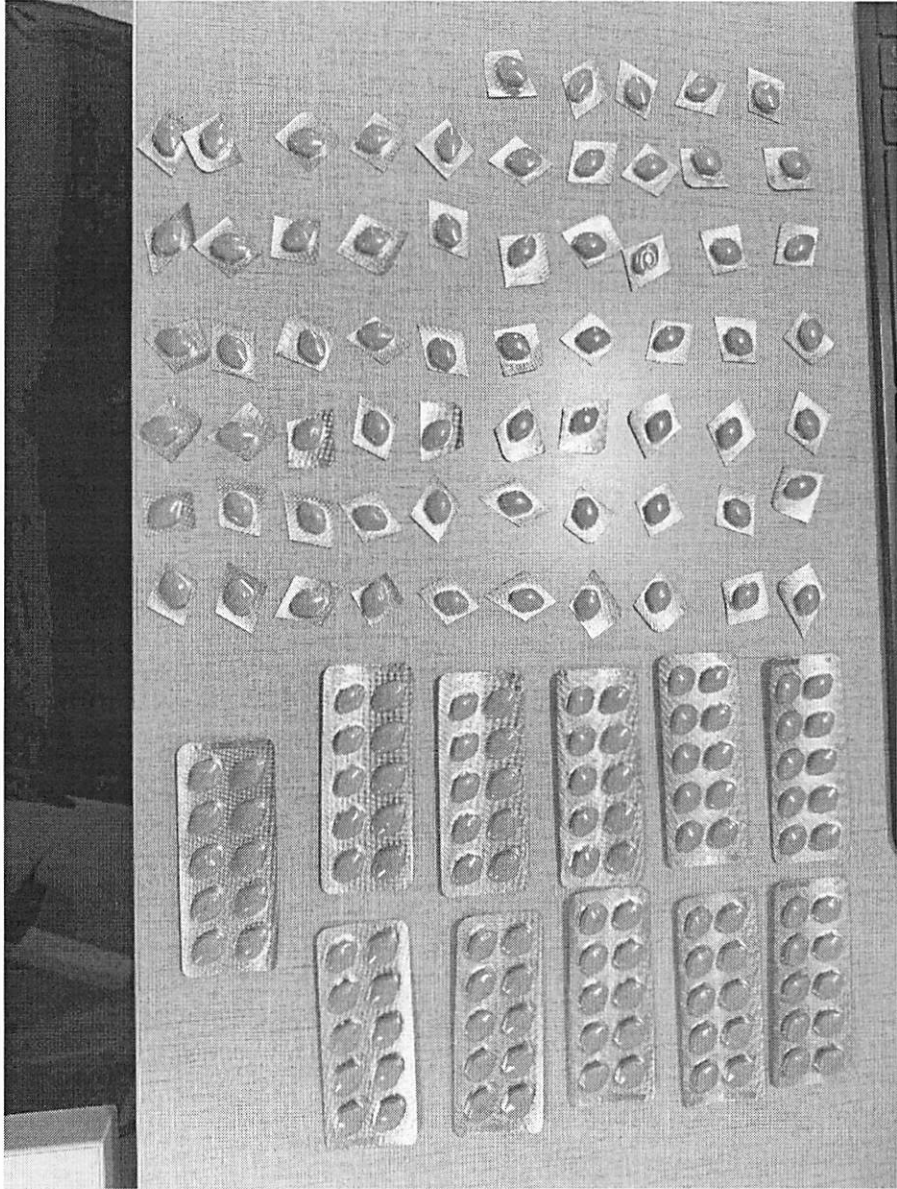


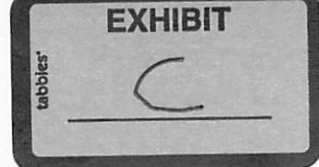

On 11/17/2025, Division of Alcohol Beverages Special Agent Diana ANDERSON and I conducted a liquor inspection at Mema Enterprises LLC, doing business as "Citco on State," located at 1914 State Rd, in the City of La Crosse, La Crosse County. This inspection was part of a wider task-force inspection in the City of La Crosse. La Crosse PD advised of multiple complaints and concerns with this business for alcohol law violations and criminal activity associated with drug use and loitering. La Crosse PD officers were present for this inspection.

We arrived at the business, and it was open to the public. Inside, we located the only employee, identified as ISRAR KHAN [REDACTED]. KHAN was a licensed operator with the City of La Crosse. KHAN advised that the owner, INDERYAS CHIRAGHDIN, was currently out of the country. I spoke with his wife by phone and advised of the inspection.

KHAN was cooperative and allowed access to the entire premises for inspection. This business possessed a "Class A" liquor/beer combo license for retail sales. There were invoices on premises, but they were disorganized and not arranged according to date/vendor. Overall, the business was in compliance with the possession and sale of intoxicating beverages.

During this inspection, I noted numerous items of concern related to possible criminal activity, that would also most likely encourage loitering. Agent ANDERSON and I found numerous "pills" in different locations. Using "drug identifier" on Drugs.com, I was able to confirm that some were diabetic medication, but there were individually wrapped blue pills labeled "Malegra 200mg," produced by "Sunrise Remedies." These pills were confirmed to be erectile dysfunction pills only available by prescription. There were about 50 individually foil packaged pills in a box under the sales counter. Based on my training and experience, I knew these were ready for individual over-the-counter sale.

Also located in the storage areas of this store were 100s of small, "one-hitter" glass pipes, most commonly used to smoke crack cocaine or methamphetamine out of. The significant amount of product indicated, the proximity to the customer sales counter, led me to believe this was a common item sold by this store. The average price appeared to be about \$4.00/pipe.

I located whippet cannisters and Nitrox-brand flavored cannisters, known to be used as inhalants. These were also present behind the sales counter. These canisters are often abused by people to get an intense, euphoric high that causes serious health concerns. Use of these products in this manner is illegal. The "Nitrox" type is branded for the use to make flavored whip cream for desserts and had no real use in the large quantities in a corner gas station/convenience store.

La Crosse PD officers and I discussed our concerns with the clerk regarding the activity that has been reported at this location. I explained that compliance with all laws is necessary in order to maintain liquor licenses.

I also suspected that there were numerous illegal vape products being sold at this store. I advised I was going to refer this case to the Cigarette/Tobacco/Vape unit for inspection.

The clerk signed the Field Report, and I left a copy for the owner's reference.

This case was turned over to La Crosse Police.

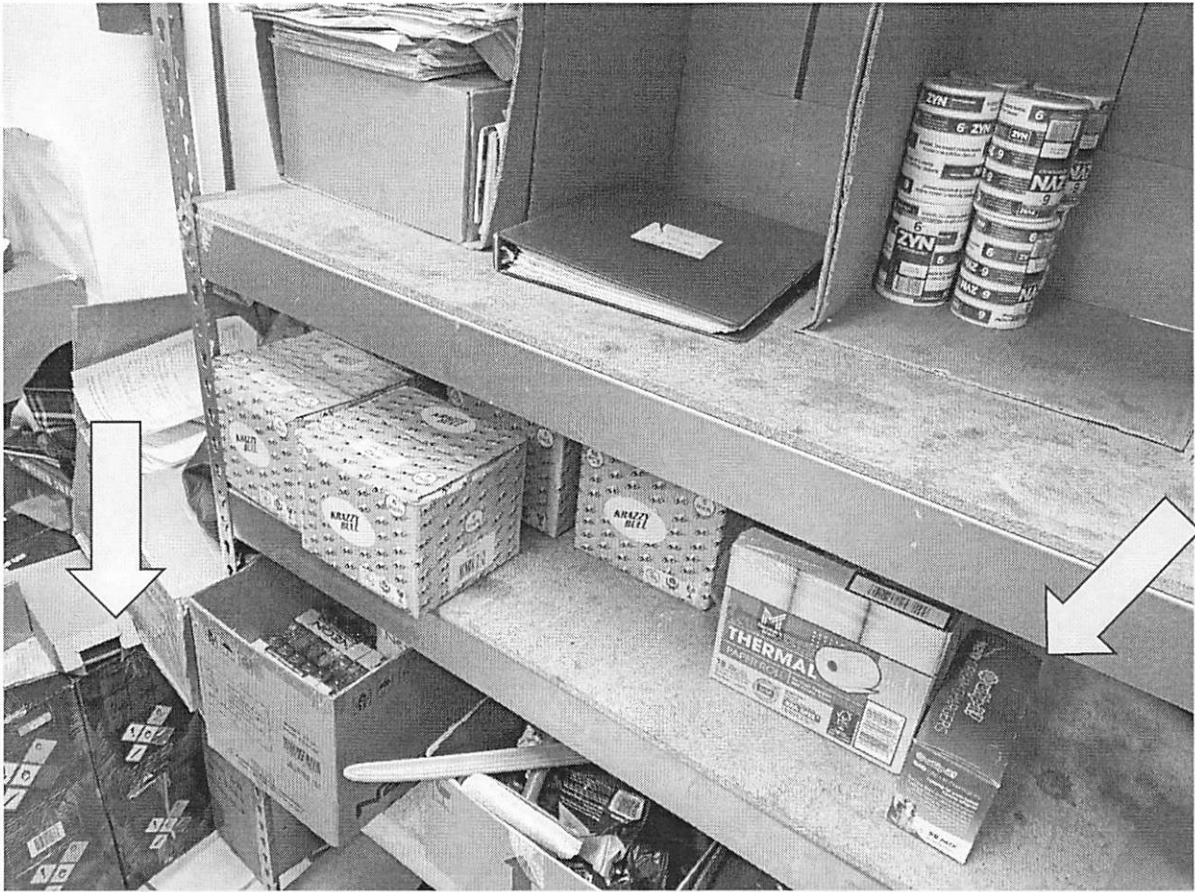

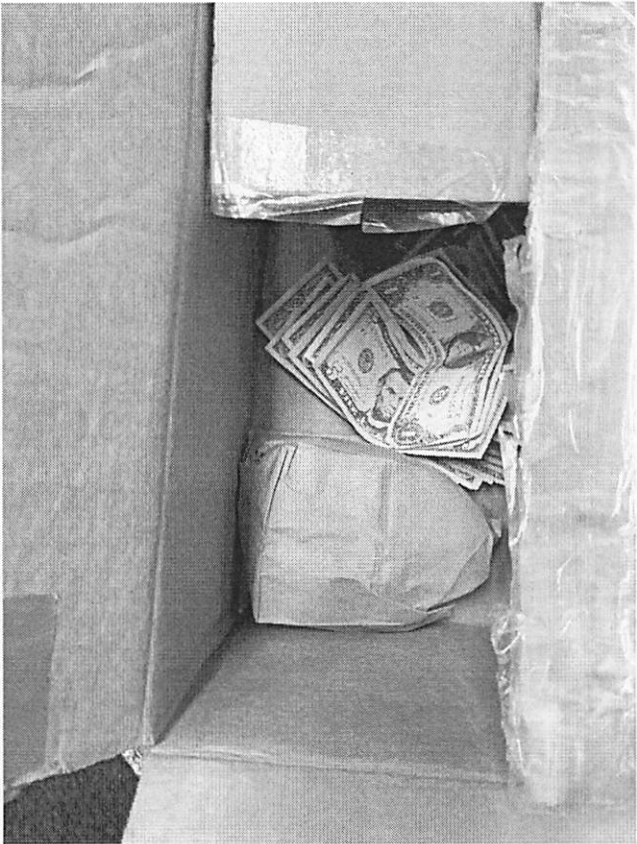
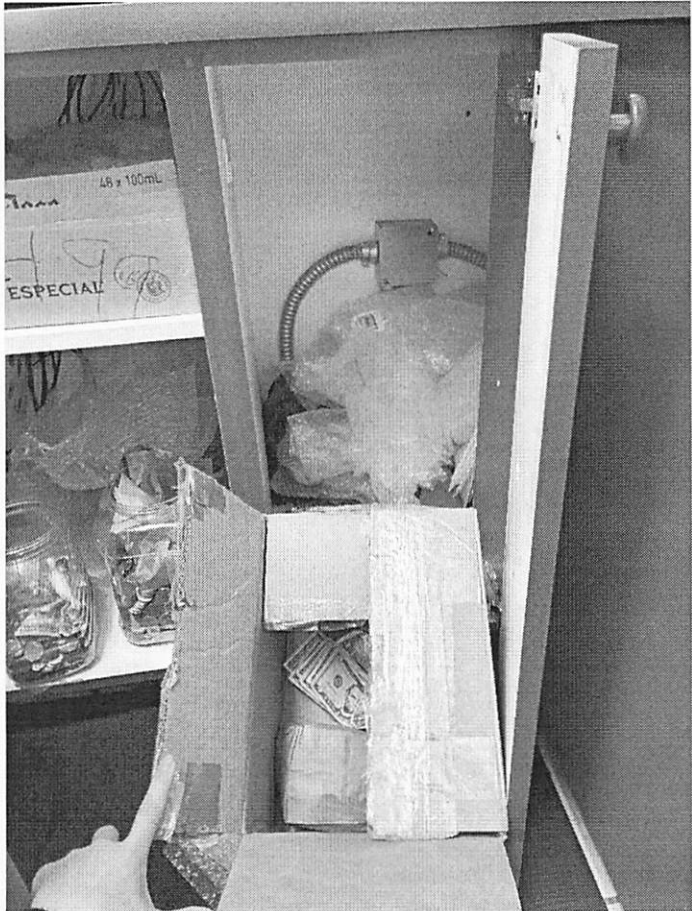

On February 4<sup>th</sup> 2026 I conducted a compliance check at the Citgo gas station located at 1914 State Rd. During the check I located 22 sildenafil tablets which are only available by prescription. This was the second time I located these illegal pills at this location. See case 25-51921 for further information on the original case. The establishment also did not have signage for their hemp-derive cannabinoid inventory. Inderyas Chiraghdin was arrested and released on a signature bond for delivery of prescription medication and cited for Failure to post signage – Hemp-derived cannabinoids.

**NARRATIVE:**

**INITIAL CALL:**

On February 4<sup>th</sup> 2026 I conducted a compliance check with the state of Wisconsin Department of tobacco and vape at the Citgo located at 1914 State Rd.

**HISTORY:**

The La Crosse Police Department has received numerous complaints about the illegal sale of tobacco and alcohol at this location. Citgo has also failed alcohol compliance checks in the past where more illegal prescription pills were located reference 25-51921. Several concerning items were located during this initial check and are still for sale at this location. These items include class pipes commonly used to consume illegal substance, gem baggies which are commonly used to store or transport illegal substance, and nitrous oxide which are used by individuals to get a short high.

**CONTACT WITH ISRAR (CHRIS) KHAN:**

Upon arrival I recognized cashier as Israr from my previous contacts and compliance checks at Citgo. I informed him we were conducting an inspection, and he was compliant and provided information he was asked for. Based on my previous compliance checks and knowledge of their distribution of illegal prescription pills I checked underneath the counter where the pills were located on my last check.

I located a cardboard box which contained numerous glass pipes wrapped in bubble wrap. I moved several of the pipes around and located 22 individually packaged pills inside of the box. These were cut individually from their original distribution packing. By piecing these today I could read "sildenafil" which is commonly known as Viagra and are used to treat erectile dysfunction but are utilized illegally by individuals on the street to enhance their sexual encounters. It also said on the package "available by prescription only". These were confirmed to be only available by prescription in the United States.

I asked Israr if they were still selling them and he stated they were. I asked them how much they were selling them for and he told me eight dollars. I asked him where he got them from and he stated, "the owner". I reminded him during our last inspection I told him they were not to sell these anymore and he stated the owner gave them to him and told him to sell them.

I then asked him what he did with the money he received from the purchase of these and he stated he put the money into the register and did not log the profit from the transaction on their point of sale system. Israr could not provide any more information about this. At this time Israr called the owner and asked him to come to the store. These pills were seized.

**MALEGRA (SILDENAFIL) TABLETS:**

I then went to confirm these tablets were available by prescription only. I utilized Drugs.com to confirm these tablets are only available by prescription. I confirmed this but had a difficult time finding the exact black color tablets and dosage of 200mg. I then contacted the Mayo Clinic pharmacy in La Crosse and spoke with pharmacist Catara M. Schneider. I provided her with the drug name and dosage, and she searched it in her database. She also confirmed the drug was only available by prescription and that the dosage available in the US is 25mg, 50mg, and 100mg. The dosage of 200mg was not available commercially in the US.

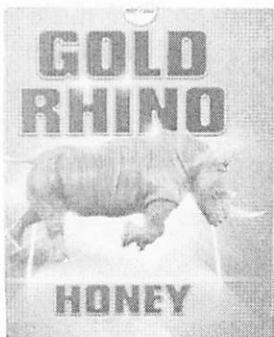

**CONTACT WITH INDERYAS (TONY) CHIRAGHDIN:**

Inderyas arrived a short time later and I spoke with about the illegal drugs which were located underneath the counter. I asked him what they were doing with the pills and he told me “they are for sex” confirming he knew what the pills were for. He also confirmed they were selling them. He told me the last time a compliance check was conducted nobody reached out to him and thought they were legal. I informed him I was trying to call him but he did not answer. He told me he was in London for two weeks with his wife and when I told him I was trying to reach him for a month he said he might have gotten my calls because of “spam”. It should be noted on my last compliance check I told Israr the pills were illegal and they could not sell them. I asked him where he received the pills from and he said “Jesse or something” and described her as a female white, over 50, with brown hair. He did not know what she drove and did not believe he had her on camera. He provided her which was labeled under “Jason Pillar” in his phone. He said he calls or texts her when they need more of the pills. He stated he calls her every couple of months. He showed me a text message on Jan. 25<sup>th</sup>, 2026, which stated:  
 Tony – “Are you coming to Citgo? This is Tony”  
 Female – “I’ll be in around 830”

He told me she was a customer and that they sell “honey and Rhino” which are male enhancement supplements that are a “sexual enhancer”. These products are often unregulated as they are not approved by the FDA. He said she he was aware of this and said since they sell this enhancer, they should sell this one instead. He told me they have been selling them for about six months. He told me the money they make from the pills they put into the register and pay the “tax” on them which is not true because they are not obtaining these legally and they do not have an item in their point of sale.



I explained to Tony the pills were only available by prescription and that he was not able to sell them as they are to be prescribed by a doctor.

I then asked Tony what he did with the Nitros oxide he had in his store. He told me they were “whip cream chargers”. I asked him if they baked at Citgo and he stated “no”, so I asked him why he had these. He said people buy them here and he does not know what they do with them afterwards. I told him I believed he was selling them to people to “get high” and he said he didn’t know what they do with them. He asked then asked “are they illegal?”. I informed them they are not illegal. He told me they do not sell individual ones but sells them by the box for \$25 dollars which did not seem to be truthful. From a financial perspective a box of 10 sells for \$15 on Amazon so to make a profit he should be selling them for at least \$75. He became very defensive when I continued to question about this and told him my frustrations behind him selling these relating to an incident where police responded to a father who was watching his two-year-old and got high with an “exotic whip” container and passed out while the child was present.

I then returned to my squad car and spoke with DA Gruenke about my findings and agreed I could issue Tony as signature bond despite the charge of selling a prescription being a class H felony. I then completed a signature bond and issued it to Tony. During my explanation of the signature bond Tony was very defensive, argumentative, and did not seem to think what he was doing was wrong. He was given his court date and signed the bond. A copy was left with him.

#### **FOLLOW UP CITATION:**

After my compliance check I spoke with the City Attorney’s Office and determined Citgo should be issued a citation for Failure to post signage – Hemp-derived cannabinoids as they did not have any signs around there products. I went to Citgo and spoke with Tony and explained the ordinance and what measures he should take to be in compliance with it. He was given the citation and advised of his court date.

#### **CONTACT WITH JESS MOULIS:**

I looked up the phone number in our local database which was associated with Jess Moulis. I called the phone number but did not get an answer. I left a voice mail asking for a call back.

I received a phone call from Jess on 03/03/26 and I informed her of the reason I was calling her. She told me she knew the owner of Citgo from when she visited there but could not remember his name and described him as “Indian”. She confirmed her number was the one provided by Tony was hers. She stated she recently changed her phone number within the last month which from my research is inaccurate as she was a victim of a crime in 2025 and provided the phone number Tony gave me. When asked if she knew her old phone number she said she did not know it and when asked how long she had her old phone number she also did not have an answer. Not knowing your old phone number or how long you had your phone number is not a reasonable answer and I believe she was being deceptive.

When asked if she had any involvement with the pills she stated she was not a “male” and did not know anything about the pills. She could not provide any other information about this.

#### **DISPOSITION:**

During a compliance check on 02/04/26 I discovered 22 illegal Sildenafil tablets which were sold illegally as they are available only by prescription. Inderyas Chiraghdin was arrested and released on a signature for Delivery of prescription medication 450.11(7)(g) and cited for Failure to post signage – Hemp-derived cannabinoids 32-165(B)(5)1. No further follow up is needed.

He told me he was in London for two weeks with his wife and when I told him I was trying to reach him for a month he said he might have gotten my calls because of "spam". It should be noted on my last compliance check I told Israr the pills were illegal and they could not sell them. I asked him where he received the pills from and he said "Jesse or something" and described her as a female white, over 50, with brown hair. He did not know what she drove and did not believe he had her on camera. He provided her which was labeled under "Jason Pillar" in his phone. He said he calls or texts her when they need more of the pills. He stated he calls her every couple of months. He showed me a text message on Jan. 25<sup>th</sup>, 2026, which stated:

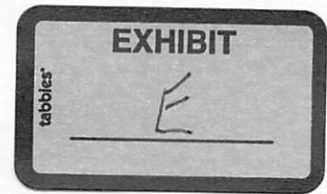

Mema Enterprises LLC, operating as Citgo and located within the City of La Crosse, currently holds alcohol and tobacco-related licenses issued by the City of La Crosse. Based upon repeated law enforcement contacts, regulatory violations, unlawful activity occurring within the establishment, and concerns regarding the qualifications of the license holder, the La Crosse Police Department recommends non-renewal of the establishment's licenses.

### **Lack of Qualifications to Hold License**

Mema Enterprises LLC member and agent, Inderyas Chiraghadin, currently has a pending criminal matter in La Crosse County Circuit Court involving a Class H felony charge related to the possession and delivery of prescription medication.

The pending criminal matter substantially relates to the licensed activity and raises concerns regarding the qualifications necessary to continue holding alcohol and tobacco-related licenses within the City of La Crosse.

### **Alcohol Compliance Violations**

On September 4, 2025, the La Crosse Police Department conducted an alcohol compliance check at the establishment.

During the compliance check, employee Muhammad Tariq sold alcohol to an underage individual in violation of Municipal Code Section 4-6 – Sale/Furnish Liquor to Underage.

Municipal Court records indicate the citation resulted in a conviction on October 10, 2025. This incident demonstrated a failure to properly verify identification and comply with municipal alcohol regulations designed to prevent underage alcohol sales.

### **Unlawful Prescription Medication and Regulatory Concerns**

On November 17, 2025, the La Crosse Police Department, in conjunction with the Wisconsin Department of Revenue, conducted a compliance inspection at the establishment reference La Crosse Police Department case number 25-51921.

During the inspection, officers located approximately 175 Malegra (sildenafil) 200mg tablets concealed beneath the sales counter. Sildenafil, commonly known as Viagra, is only legally available within the United States by prescription. An employee informed officers the pills were being sold to customers for approximately \$7 per tablet. Officers advised staff that the sale of the pills was unlawful and seized the medication.

In addition to the unlawful prescription medication, officers observed several concerning items commonly associated with illegal drug activity and substance abuse, including:

- Numerous glass pipes commonly associated with illegal drug consumption.
- Several large “Exotic Whip” Nitrous Oxide containers and thousands of flavored nitrous oxide canisters commonly referred to as “whippets.”
- Mushroom products and THC Delta-8 or THC-A products intended to produce psychoactive effects.

As a result of the investigation, Chiraghdin was arrested and later released on a signature bond for delivery of prescription medication.

Officers also observed the establishment’s alcohol purchase invoices were not organized or maintained in the manner required by state law and regulatory standards.

### **Continued Unlawful Activity After Law Enforcement Intervention**

On February 4, 2026, the La Crosse Police Department conducted a follow-up compliance inspection at the establishment reference La Crosse Police Case number 26-04730.

During the inspection, officers again located sildenafil 200mg tablets (22) behind the sales counter hidden in a cigar box underneath some other items. This marked the second occasion officers discovered illegal prescription medication being stored and sold from the establishment.

Officers also recovered portions of the original packaging clearly labeled “available by prescription only.” During contact with officers, Inderyas Chiraghdin acknowledged the intended purpose of the pills and stated, “they are for sex.” During this conversation he also referenced he already sells “Rhino” pills, an unregulated over the counter male sexual enhancement supplement which were displayed for sale at the check out area in plain view at eye level.

As a result of the investigation, Chiraghdin was arrested and later released on a signature bond for delivery of prescription medication.

The investigation further revealed the sildenafil pills were not commercially approved for distribution within the United States and that the 200mg dosage exceeded prescription dosages legally available within the United States.

During the same inspection, officers also discovered the establishment failed to display required signage related to hemp-derived cannabinoid inventory. Mema Enterprises LLC was cited for Failure to Post Signage – Hemp-Derived Cannabinoids in violation of Municipal Code Section 32-165. Municipal Court records indicate the citation resulted in a conviction on February 26, 2026.

### **False or Misleading Application Information**

Municipal Code Sections 4-72(b)(6) and 4-142(b)(6) governing applications for intoxicating liquor and fermented malt beverage licenses provide:

“Any false statement contained in such application shall automatically nullify any license issued pursuant thereto.”

The 2026 renewal applications submitted by Mema Enterprises LLC failed to disclose the Municipal Code Section 32-165 conviction against the establishment.

Additionally, the renewal application acknowledged the pending felony matter but included the following statement:

“A vendor sold me an erectile product which, unknown to me, might or might not contain a prescription medication for erectile dysfunction.”

This statement directly contradicted statements made by Inderyas Chiraghdin during the February 4, 2026 inspection. During law enforcement contact, Chiraghdin acknowledged the nature and intended use of the pills.

Further investigation revealed the individual referenced as the alleged “vendor” was not a vendor associated with the business. The individual in question denied during an interview of providing any medications to Chiraghdin. Investigators also confirmed the individual has a history of illegal drug activity and criminal charges within the City of La Crosse.

The inconsistencies between the renewal application and statements made during the investigation raise concerns regarding the accuracy and truthfulness of the submitted application materials.

### **Crime Stoppers Tips and Community Reputation**

The La Crosse Police Department has received Crime Stoppers tips and community information regarding unlawful activity occurring at the establishment.

On July 4, 2025, the department received Crime Stoppers Tip #459-C8910 alleging an employee was routinely selling alcohol to underage individuals without checking identification and attempting to meet minors after work hours. The tip indicated this behavior had allegedly been occurring for several years.

Additionally, over the past several years, the establishment has developed a reputation within the community as a location where minors can easily obtain alcohol or tobacco products. Several School Resource Officers have communicated concerns and information received from students regarding the ease of obtaining these products from the establishment.

The establishment has also become known within the community as a location where items associated with unlawful drug activity can be obtained. In previous years, the La Crosse Police Department became aware of “brown bag specials” sold by the establishment containing combinations of items commonly associated with illegal drug use. Although the individual items were legal to possess, the manner in which they were packaged and marketed raised concerns regarding their intended use.

### **Conclusion**

Based upon my training, experience, and review of enforcement activity involving the establishment, Mema Enterprises LLC has demonstrated an ongoing pattern of unlawful activity, regulatory noncompliance, and conduct inconsistent with the responsibilities required of a licensed establishment within the City of La Crosse.

The continued sale and possession of unlawful prescription medication, failure to comply with alcohol regulations, misleading application information, and ongoing community concerns present significant public safety and regulatory concerns. Additionally, the pending felony criminal matter involving the license agent substantially relates to the licensed activity and calls into question the qualifications necessary to continue holding these licenses.

For these reasons, the La Crosse Police Department recommends non-renewal of the licenses held by Mema Enterprises LLC.
