What benefit has your organization provided to the La Crosse community, and specifically to the City, in 2024?

The Hmong Cultural and Community Center services a diverse community, including youth, adults, seniors, and people with disabilities, through its programs and services. Many of these families are low-income and rely on public assistance. The Center is also the only organization in La Crosse County offering traditional memorial services, which are a vital part of the Hmong funeral customs. In addition, the organization provides essential translation and interpreting services and assists with completing applications for citizenship, passports, social security, and public assistance.

Last year, our annual Hmong New Year event attracted between 10,000 and 15,000 visitors from outside La Crosse over the span of 2-3 days. This event created over 600 hotel rooms for one weekend.

HCCC also collaborate with the School District of La Crosse for over 15 years to teach Hmong History to all 4th graders as part of the social studies curriculum. For the last two years, HCCC was able to expand this program to other school districts in the Coulee Region.

The Hmong Cultural and Community Center (HCCC) also serves as a voting site for two districts, further contributing to the community by providing accessible voting opportunities for local residents.

The center is the only place in La Crosse County that offers traditional memorial services to the Hmong community, which is an essential part of Hmong funeral traditions. These services provide culturally specific and highly valued support to grieving families, ensuring the preservation of cultural practices and providing the community with a safe space to grieve and honor their loved ones.

What does your organization have planned for the remainder of 2024 (that is of benefit to La Crosse, and specifically the City)?

HCCC continues to look for options to expand program to meet the needs of other members. Currently, all programs are housed at the center with participants from Holmen and Galevsille. HCCC would like to expand programs to Holmen and Onalaska.

What does your organization plan to accomplish with the help of City funding in 2025?

With the help of City funding in 2025, the Hmong Cultural and Community Center (HCCC) plans to accomplish several key initiatives that will significantly benefit the broader La Crosse community. These initiatives are aimed at enhancing services, expanding outreach, and fostering deeper community engagement.

With City funding, HCCC plans to offer more educational programs and cultural events that highlight Hmong traditions, arts, and heritage. These programs will foster greater cultural understanding and promote inclusivity within La Crosse. HCCC also plans to continue with current programs to help with wellness and mental health in the community.

The continue trust and support from the City As a voting site for two districts, Hmong Cultural and Community Center (HCCC) recognizes that handicap accessibility is crucial to ensure that all individuals, including those with disabilities, can participate in the voting process with dignity and confidence. Currently, a bell is available for assistance, but we believe that having handicap accessible doors will provide even greater independence and remove any potential barriers to voting. With city funding, HCCC would like to update doors for handicap accessible. This project is estimated to be \$10,000.

Hmong Cultural and Community Center (HCCC) recognizes that cultural preservation is crucial to maintaining and celebrating the rich heritage of the Hmong community, both within La Crosse and beyond. This project is designed to protect, promote, and honor Hmong culture by ensuring that future generations maintain a strong connection to their roots, language, traditions, and customs. At the same time, the initiative will foster cross-cultural understanding and appreciation within the broader community.

HCCC's commitment to cultural preservation is demonstrated through a variety of ongoing programs aimed at engaging all age groups and strengthening cultural pride. These programs include:

Hmong Education Project focuses on educational initiatives that promote language learning, academic success, and cultural awareness which. It ensures younger generations stay connected to their heritage while providing them with the academic tools they need to thrive.

Niam Tsev Koom Siab (Mother's Unity) – Hmong Women Line Dance Program brings together Hmong women to learn and celebrate traditional dance as part of their cultural identity. It offers an opportunity for bonding, empowerment, and the transmission of cultural values to the next generation.

Youth Cultural Dance program encourages Hmong youth to participate in traditional cultural dance. Through this, the younger generation learns the significance of dance in Hmong culture and the stories it tells, all while developing a sense of pride in their heritage.

HCCC's cultural class offer hands-on learning experiences where participants can explore Hmong language, arts, crafts, history, and traditional practices. The aim is to educate community members of all ages about their cultural roots and preserve vital traditions for future generations.

Together, these programs play a pivotal role in sustaining the cultural legacy of the Hmong community in La Crosse. Through language, dance, and cultural classes, HCCC ensures that Hmong traditions remain alive, vibrant, and passed down from generation to generation, while also fostering greater understanding and respect among the broader community.

By continuing to invest in and expand these cultural preservation initiatives, HCCC plays a critical role in strengthening the cultural fabric of the Hmong community and promoting cross-cultural exchange in La Crosse.

Funding will be used to acquire educational materials for the cultural classes, such as Hmong language books, instructional tools, and dance costumes to prevent avoid anyone participant from financial hardship.
