At this time I was advised J&A has approved the event. I would also like to make sure the sidewalk is closed/detoured in front of the Charmant to the outdoor area- 100 State St, for alcohol compliance in a public area or for them to make sure patrons are not carrying open intoxicants on the sidewalk if not closed. City Engineer Jamie Hassemer also responded with the closure of the sidewalk the additional requirements/additional barricades needed.
